## CR4825 BLIND KIT



**STEP 1.** Thread bungee cords through sleeves on the bottom of the blind.

**STEP 2.** Wrap blind around front and 2 sides of top portion of the ladderstand.

**STEP 3.** Attach to stand by wrapping top edge of blind over shooting rail (A) and securing with attached fasteners (B).

**STEP 4.** Secure bottom by hooking bungee cords to opposite corners (C).
