## Introduction

Thank you for purchasing this high-quality dual-port USB 3.0 PCI Express Card adapter. The USB Express Card is ideal for external storage devices, digital cameras, card readers, MP3 players, and all other USB devices.

USB 3.0 supports transfer speeds of up to 5Gbps. It is also backwards compatible with USB 2.0/1.1 devices.

## Important safety instructions

- Always read the safety instructions and *User Guide* carefully. Keep the *User Guide* for future reference.
- Do not drop or allow forceful impacts to the product, or install it in locations exposed to heavy vibrations.
- Do not disassemble or modify the product in any way. Disassembly or modification may not only void the warranty, but may also cause damage or lead to fires or electric shock.
- Do not use or store the product in damp locations. Liquid entering the product may cause damage or lead to fires or electric shock.
- Before removing the PCI Express adapter from its package, safely discharge any static electricity build-up which may damage the computer or the PCI Express Card adapter by touching an unpainted piece of metal. Handle the card by the metal mounting bracket and printed circuit board edges only.

- Avoid touching the gold-plated PCIe bus and the onboard electronic components.
- This product is for general computer use. It is not to be used as equipment requiring exceptional reliability, particularly when the breakdown or malfunction of this product may jeopardize life or health (such as aerospace equipment, atomic power control systems, traffic-related equipment, transportation equipment, industrial robotics, combustion equipment, various safety devices, and life-support systems).

- Compatible with a standard PCI Express slot.





# Installing your USB 3.0 PCI Express Card

## System requirements

- PCI Express-enabled system with an available PCI Express x1 slot. (We recommend PCI Express 2.0)
- Windows® 8, Windows® 7, Windows Vista®, Windows® XP

### Cautions

- Opening your computer's case may void your computer's warranty. Contact your computer's manufacturer before opening the case to make sure that you do not void the warranty.
- Before touching any electronic components, make sure that you first touch an unpainted, grounded metal object to discharge any static electricity stored on your clothing or body.
- Handle the PCI Express Card adapter by the metal mounting bracket and the printed circuit board (PCB) edges only. Avoid touching the gold-plated PCIe bus and the onboard electronic components.

### Note

In order to get USB 3.0 SuperSpeed performance, use a PCI Express Ver2.0 slot for the card installation. Refer to the user manual for your system or motherboard to find the correct slot.

# Installing the hardware

**Note**


PC components often have sharp metal edges. To prevent injury, exercise caution when removing/installing components from your PC, especially when exerting force.

**To install the card:**

- 1 Turn off your computer and unplug the power cord and all cables.
- 2 Remove your computer's case cover. See your computer's user guide for information about removing the cover.
- 3 Locate an available PCI Express slot, remove the screw that secures the backplate (the small piece of metal that covers the opening for the PCI card on the back panel of your computer), then remove the backplate. If you are using a slim desktop computer, attach the included short backplate prior to installation.

To change backplates, remove the screws that secure the standard backplate to the PCI card, remove the standard backplate, then attach the short backplate with the screws you removed.

- 4 Carefully insert the adapter into the PCIe x1 slot, seating it firmly into the slot. Do not touch the metal connector on the adapter.
- 5 Connect an available floppy 4-pin power plug from your PC's power supply to the adapter card's 4-pin power connector.



- 6 Secure the adapter to the case using the screw you removed from the backplate.
- 7 Reinstall your computer's case cover.
- 8 Plug in the power cord and other cables, and then turn on your computer.

# Windows driver installation

**Note**


The USB 3.0 driver is only for the Windows operating system. (Only Windows XP through Windows 7 requires the driver, Windows 8 does not.) It does not support Mac and Linux operating systems.

## To install the Windows driver:

- 1 Save all files and close all programs. Insert the included driver CD into your optical drive. The driver home page opens.




- 2 Click **Install Driver**. The installation wizard opens.



- 3 Click **Next**, then follow the on-screen instructions to install the driver. The *End User License Agreement* page opens.
- 4 Select **I accept the terms of the license agreement**, then click **Next**. The install screen opens.
- 5 Click **Install** to begin the installation. When the installation process is complete, the *InstallShield Wizard Complete* screen opens.
- 6 Click **Finish** to complete the process.

**To verify the driver installation:**

- 1 Click **Start**, right-click **Computer (or My Computer)**, then select **Properties**.
- 2 Click **Device Manager**, then click **Universal Serial Bus controllers**.
- 3 If the device has been correctly installed, its sub-entry should be displayed as **Renesas Electronics USB 3.0 Host Controller** and **Renesas Electronics USB 3.0 Root Hub**.

**To uninstall the Windows driver:**

- 1 Click the **Add or Remove Programs** tab (**Uninstall a Program** in Windows 7) in the Windows **Control Panel**.
- 2 Click the **Remove** button to uninstall the Insignia USB 3.0 PCI Express Card Driver.
- 3 Click **Finish** to complete the driver uninstall procedure.

## Troubleshooting

Check the following guide for the possible causes and solutions for a problem before contacting the nearest service center or dealer for repairs.

Symptom	Solution
The Windows Device Manager does not show the Renesas Electronics USB 3.0 Host Controller.	<ul style="list-style-type: none"> <li>• Make sure that the PCI Express Card adapter is correctly installed in the PCIe slot.</li> <li>• Remove the adapter and try a different PCIe slot in case the bus has conflicts.</li> <li>• Repeat the driver installation procedure, then make sure that the device exists. Right-click <b>Computer</b> in the <i>Start</i> menu (or <b>My Computer</b> on your desktop), click <b>Properties</b>, then click the <b>Device Manager</b>. If the <b>Renesas Electronics USB 3.0 Host Controller</b> is shown, the PCI Express Card adapter is working correctly.</li> <li>• Make sure that your computer's operating system is updated to the latest version.</li> </ul>
No USB peripheral is detected by the computer.	<ul style="list-style-type: none"> <li>• Make sure that all cables are correct and securely connected.</li> <li>• Make sure that the USB device's power is turned on.</li> <li>• Make sure that the devices are getting enough power.</li> <li>• Make sure to plug the 4-pin power cable into the adapter card to provide sufficient power to USB devices, or use self-powered USB devices.</li> <li>• A long cable may cause poor performance. A USB repeater must be used if the cable is longer than 3.5 meters.</li> <li>• Make sure that there is no problem with the adapter installation.</li> </ul>
Conflict with other Windows USB PCI adapters.	<ul style="list-style-type: none"> <li>• Conflicts are indicated by an entry in the <b>Device Manager</b> with a red X or yellow exclamation point.</li> <li>• Turn off your computer and move the adapter to another available slot, then re-install the USB 3.0 driver.</li> <li>• An exclamation point in the <b>Device Manager</b> usually means there is a resource conflict between this adapter and another adapter in your system. Move the adapter to another slot, then restart your computer. Windows will re-configure itself and re-assign resources. Check your device manager again.</li> </ul>

# One-year limited warranty - Insignia

## Definitions:

The Distributor\* of Insignia branded products warrants to you, the original purchaser of this new Insignia-branded product ("Product"), that the Product shall be free of defects in the original manufacture of the material or workmanship for a period of one (1) year from the date of your purchase of the Product ("Warranty Period").

For this warranty to apply, your Product must be purchased in the United States or Canada from a Best Buy branded or Future Shop branded retail store or online at [www.bestbuy.com](http://www.bestbuy.com), [www.bestbuy.ca](http://www.bestbuy.ca), or [www.futureshop.ca](http://www.futureshop.ca) and is packaged with this warranty statement.

## How long does the coverage last?

The Warranty Period lasts for 1 year (365 days) from the date you purchased the Product. Your purchase date is printed on the receipt you received with the Product.

## What does this warranty cover?

During the Warranty Period, if the original manufacture of the material or workmanship of the Product is determined to be defective by an authorized Insignia repair center or store personnel, Insignia will (at its sole option): (1) repair the Product with new or rebuilt parts; or (2) replace the Product at no charge with new or rebuilt comparable products or parts. Products and parts replaced under this warranty become the property of Insignia and are not returned to you. If service of Products or parts are required after the Warranty Period expires, you must pay all labor and parts charges. This warranty lasts as long as you own your Insignia Product during the Warranty Period. Warranty coverage terminates if you sell or otherwise transfer the Product.

## How to obtain warranty service?
