# Wall Mount Docking Station for TPMC-3X: TPMC-3X-DSW

#### Introduction

The Crestron® TPMC-3X-DSW is a wall-mountable docking station and battery charger designed specifically for use with the Isys® TPMC-3X Handheld WiFi Touch Screen (sold separately). It mounts to a 1-gang standard electrical box or plaster ring and is finished using any off-the shelf decorative faceplate (not included). It features a magnetic catch for easy docking and extra stability. Power may be provided by the Cresnet® control bus\* or any Crestron 24 VDC regulated power source.

It is available in white or black.

**NOTE:** The TPMC-3X-DSW is not compatible with the TPMC-3X-LP.





#### Setup

#### Installation

To prevent overheating, do not operate this product in an area that exceeds the environmental temperature range listed in the table of specifications.

The following tools and accessories are required for installation of a TPMC-3X-DSW:

- Standard 1-gang electrical box (not supplied)
- Flat head screwdriver (not supplied)
- Two #06-32 x 1" screws (included)


After Cresnet power (or other Crestron 24 Volt power source) wiring has been installed and verified, use the following procedure to install the TPMC-3X-DSW.

- 1. Turn system power **OFF**.
- 2. Connect the power supply cable to the **24** and **G** pins on the TPMC-3X-DSW's **PWR** connector.
- 3. Attach the TPMC-3X-DSW to the electrical box using the two supplied #06-32 x 1" screws (2013235).

**CAUTION:** Excess wire that is pinched between the TPMC-3X-DSW and the electrical box could short out. Make sure all excess wire is completely inside the electrical box and not between the box and the TPMC-3X-DSW.

- 4. Attach the faceplate using the screws that came with the faceplate.
- 5. Turn system power **ON**.





TPMC-3X-DSW Troubleshooting

TROUBLE	POSSIBLE CAUSE(S)	CORRECTIVE ACTION
The internal battery of the touch screen	The contacts on the TPMC-3X-DSW are dirty.	Remove the touch screen and clean the contacts.
does not recharge.	The internal battery cannot retain a charge.	Undock the touch screen and replace the internal battery.
	The <b>PWR</b> connector is not secure.	Remove the touch screen and check that the connector is secure.
	Incorrect power supply.	Use a Crestron power supply with sufficient power.

#### Merchandise Returns / Repair Service

Only authorized Crestron dealers may contact the factory and request an RMA (Return Merchandise Authorization) number. Enclose a note specifying the nature of the problem, name and phone number of contact person, RMA number and return address.
- 2. Products may be returned for credit, exchange or service with a Crestron Return Merchandise Authorization (RMA) number. Authorized returns must be shipped freight prepaid to Crestron, 6 Volvo Drive, Rockleigh, N.J. or its authorized subsidiaries, with RMA number clearly marked on the outside of all cartons. Shipments arriving freight collect or without an RMA number shall be subject to refusal. Crestron reserves the right in its sole and absolute discretion to charge a 15% restocking fee plus shipping costs on any products returned with an RMA.
- 3. Return freight charges following repair of items under warranty shall be paid by Crestron, shipping by standard ground carrier. In the event repairs are found to be non-warranty, return freight costs shall be paid by the purchaser.

#### **Crestron Limited Warranty**

Crestron Electronics, Inc. warrants its products to be free from manufacturing defects in materials and workmanship under normal use for a period of three (3) years from the date of purchase from Crestron, with the following exceptions: disk drives and any other moving or rotating mechanical parts, pan/tilt heads and power supplies are covered for a period of one (1) year; touch screen display and overlay components are covered for 90 days; batteries and incandescent lamps are not covered.



Crestron is not liable for any claim made by a third party or made by the purchaser for a third party.

Crestron shall, at its option, repair or replace any product found defective, without charge for parts or labor. Repaired or replaced equipment and parts supplied under this warranty shall be covered only by the unexpired portion of the warranty.

Except as expressly set forth in this warranty, Crestron makes no other warranties, expressed or implied, nor authorizes any other party to offer any warranty, including any implied warranties of merchantability or fitness for a particular purpose. Any implied warranties that may be imposed by law are limited to the terms of this limited warranty. This warranty statement supersedes all previous warranties.
