

Setup

Step 1: Prerequisite software and hardware

- 1) A free Ethernet port on a router directly connected to the Internet.
- 2) A PC or other device with a web browser.

Step 2: Register your EAGLE™

Your **EAGLE™** must be registered with your utility to connect to the smart meter. You will need to contact your utility with two numbers (MAC Address and Install Code) that can be found on the Information Label.

Note that it may take some time for your utility to enable the smart meter to connect with your device. You must wait until this process is complete before proceeding; your **EAGLE**™ will not function correctly until the smart meter is enabled.

Step 3: Power up your EAGLE™

- Plug the Ethernet cable into a port on your router, and the other end into the Ethernet port on your EAGLE™.
- 2) Plug the AC adapter into a nearby wall outlet, and plug the other end into the power socket on your **EAGLE**™.
- 3) Allow two minutes for the device to boot up. You should see that 3 of the 4 status LED lights (not the Cloud) are all on continuously. This indicates that the unit is functioning normally.





Step 4: Connect to your EAGLE™

You should now be able to connect to your **EAGLE™** using a web browser. The computer running the web browser must be **connected to the same router** as the **EAGLE™**, and the computer must also be running multicast Domain Name System (mDNS), which is known as Bonjour on Apple computers. mDNS may be already installed on your computer, as many printers and Apple's iTunes use this protocol. If you need to manually install mDNS on your Windows PC, you can find instructions at: http://support.apple.com/kb/DL999


Type the Local Web Address of the **EAGLE**™ (found on the Information Label) into the URL field of your web browser and connect. When your web browser connects to the **EAGLE**™, you should see the Web Viewer "Usage" page:



Note that you may have to wait a short while until the data is loaded

Connecting to a Cloud Service

To set up a connection to the Cloud Service of your choice, click the **Settings** button in the lower right corner of the Web Viewer. Then click the white triangle on the right side of the "Cloud" bar to get the Cloud sub-page.



Select the Cloud Service you want from the drop-down menu for "Provider", and click the "Set Cloud" button at the bottom right. To complete your connection to the Cloud Service, you will have set up an account with them. You will need to indicate that data will be coming from a Rainforest **EAGLE™** device, and supply the 6-digit Cloud ID that can be found on the Information Label on the underside of your **EAGLE™**.
