## INSTALLATION TIPS

- Ensure carbonated water dispenses from labeled CO<sub>2</sub> tap
- Installation hole: 1 3/8" (35mm)
- Maximum counter thickness: 4" (100mm)
- Ensure all regulating valves are pointed in down direction (open) before adjustment
- Adjust each regulating lever so unit dispenses 1/4 gallon (1 L) water in 20 seconds

Regular preventative maintenance should be performed to ensure optimum performance


