





### STEP 1


Connect Front Frame (3) and Rear Base (2) to Main Frame (1) using:

4 x (19) Bolt

8 x (18) Washer

4 x (20) Nylon Lock Nut





### STEP 2

Connect Swing Tube (8) to Swing Arm as shown using:


1 x (37) Collar

1 x (34) Bolt

Slide Big Roller Pad (39) onto Swing Tube (8) and secure using:

1 x (37) Collar 1 x (34) Bolt





## STEP 3

Attach Right and Left Handles (11,12) using:

2 x (19) Bolt

4 x (18) Washer

2 x (20) Nylon Lock Nut

#### STEP 4

Attach Side Angle Frame (4) using:

4 x (19) Bolt


8 x (18) Washer

 $4 \times (20)$  Nylon Lock Nut  $2 \times (21)$  Plate

## STEP 5

Slide Stopper Prone (17) into Front Frame for range of motion limiter.





#### STEP 6

Complete Adjustable Roller Pad Frame (10) as shown using:

2 x (43) Foam Pad

2 x (33) Big Plug


Slide into frame and secure with Pop Pin.

**Note:** It is suggested that a rubber mallet be used to secure plugs.

## STEP 7

Slide Back Pad Adjustable Frame (9) into frame and secure with Pop Pin.





#### STEP 8

Attach Back Pad (16) using:

2 x (28) Bolt

2 x (27) Washer

Connect Seat Pad (15) to Adjustable Seat Bracket (13) using:

4 x (28) Bolt

4 x (27) Washer

Connect Adjustable Seat Bracket (13) to frame as shown using:

1 x (14) Shaft with Screw End 2 x (18) Washer

2 x (20) Nylon Lock Nut


1 x (32) L Pin

# KEYS FITNESS PRODUCTS, L.P. LIFETIME WARRANTY



This Warranty applies in the United States and Canada to products manufactured or distributed by Keys Fitness Products, LP ("Keys") under the KEYS brand name. The warranty is non-transferable and valid only to the original purchaser.

Keys warrants that the Product you have purchased for non-commercial, personal, family, or household use from Keys or from an authorized Keys reseller is free from defects in materials or workmanship under normal use during the warranty period. Your sales receipt, showing the date of purchase of the Product, is your proof of purchase. This warranty only extends to you, the original purchaser. It is not transferable to anyone who subsequently purchases or acquires the Product from you. This Warranty becomes VALID ONLY if the product is pur-

chased through a Keys Fitness authorized dealer unless otherwise authorized by Keys Fitness in writing and must be assembled / installed according to the instructions included with the Product.

In a light institutional setting, Keys will extend a one year limited warranty to the original purchaser.

During the warranty period Keys will repair or replace (at Keys' option) the product if it becomes defective, malfunctions, or otherwise fails to conform with this Warranty under normal use. In repairing the Product, Keys may replace defective parts with new or, at the option of Keys, serviceable used parts that are equivalent to new parts in performance. All exchanged parts and Products replaced under this warranty will become the property of Keys. Keys reserves the right to change manufacturers of any part to cover any existing warranty.

This warranty DOES NOT COVER shipping charges, export taxes, custom duties and taxes, or any other charges associated with transportation of the parts or Product. To obtain warranty service, you must contact a Keys authorized retailer, service technician or Keys Fitness at our phone number located in this manual. Any parts determined to be defective must be returned to Keys to obtain warranty service. You must prepay any shipping charges, export taxes, custom duties and taxes, or any other charges associated with transportation of the parts or Product. In addition, you are responsible for insuring any parts or Product shipped or returned. You assume the risk of loss during shipment. You must present Keys with proof-of-purchase documents (including the date of purchase). Any evidence of alteration, erasure or forgery of proof-of-purchase documents will be cause to void this Warranty.

This Warranty does not extend to any product not purchased from Keys or from an authorized Keys reseller. This Limited Warranty does not extend to any Product that has been damaged or rendered defective; (a) as a result of accident, misuse, or abuse; (b) by the use of parts not manufactured or sold by Keys; (c) by modification of the Product: (d) operation on incorrect power supplies; or (e) as a result of service by anyone other than Keys, or an authorized Keys warranty service provider. Product on which the serial number has been defaced or removed is not eligible for warranty service. Should any Product submitted for warranty service be found ineligible, an estimate of repair cost will be furnished and the repair will be made if requested by you upon Keys' receipt of payment or acceptable arrangements for payment.
