

OPERATOR SAFETY

 Dress properly. Always wear safety glasses or similar eye protection when operating, or performing maintenance, on your unit (safety glasses are available). Eye protection should meet the requirements of ANSI Z87.1.

- · Always wear face or dust mask if operation
- Always wear heavy, long pants, long sleeves, boots, and gloves. Wearing safety leg guards is recommended.
- Always wear foot protection. barefoot or wear sandals. Stay clear of spinning line.

UNIT / MAINTENANCE SAFETY

- · Disconnect the spark plug before performing maintenance (except carburetor adjust-
- · Look for and replace damaged or loose parts before each use. Look for and repair fuel leaks before use. Keep in good working
- Replace trimmer head parts that are chipped, cracked, broken, or damaged in any other way before using the unit.
- Maintain unit according to recommended procedures. Keep cutting line at proper
- Use only 0.080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope,
- Install required shield properly before using the unit. Use only specified trimmer head; make sure it is properly installed and securely fastened.
- Make sure unit is assembled correctly as shown in this manual.
- Make carburetor adjustments with lower end supported to prevent line from contacting any object.
- Keep others away when making carburetor adjustments.
- Use only recommended Weed Eater® accessories and replacement parts.
- Have all maintenance and service not explained in this manual performed by an authorized service dealer.

FUEL SAFETY

- Mix and pour fuel outdoors.
- Keep away from sparks or flames.
- Use a container approved for fuel.
- Do not smoke or allow smoking near fuel or
- · Avoid spilling fuel or oil. Wipe up all fuel spills.
- Move at least 10 feet (3 meters) away from fueling site before starting engine.

- · Stop engine and allow to cool before removing fuel cap.
- Always store gasoline in a container approved for flammable liquids.

CUTTING SAFETY

WARNING: Inspect the area before each use. Remove objects (rocks, broken glass, nails, wire, etc.) which can be thrown by or become entangled in line. Hard objects can damage the trimmer head and be thrown causing serious injury.

- Use only for trimming, mowing, and edging. Do not use for pruning or hedge trimming.
 Keep firm footing and balance. Do not over-
- reach.
- Keep all parts of your body away from muffler and spinning line. Keep engine below waist level. A hot muffler can cause serious burns.
- Cutting on left side of the shield will throw debris away from the operator.
- Use only in daylight or good artificial light.

TRANSPORTING AND STORAGE

- · Allow the engine to cool; secure unit before storing or transporting in vehicle.
- Empty fuel tank before storing or transporting the unit. Use up fuel left in the carburetor by starting engine and letting it run until it stops.
- Store unit and fuel in an area where fuel vapors cannot reach sparks or open flames from water heaters, electric motors or switches, furnaces, etc.
- Store unit so line limiter blade cannot accidentally cause injury. Unit can be hung by the tube.
- Store the unit out of the reach of children If situations occur which are not covered in this manual, use care and good judgment. If you need assistance, call 1-800-554-6723.

ASSEMBLY

WARNING: Make sure unit is properly assembled and all fasteners are secure.


ADJUST THE HANDLE

Loosen wing nut or plastic knob on handle.Rotate handle to upright position and tighten in a comfortable position between the trigger and the safety label on the tube. Tighten handle securely.

ATTACH THE SHIELD

WARNING: The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter blade which cuts excess line. The line limiter blade (on underside of shield) is sharp and can cut you.

- · Remove wing nut from shield.
- Insert bracket into slot as shown.
- Pivot shield until bolt passes through hole
- · Securely tighten wing nut onto bolt.



FUEL YOUR UNIT


This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eater brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUÉL SAFETY

STARTING

HOW TO STOP YOUR UNIT

To stop the engine, push and release the engine STOP switch. The switch will automatically return to the ON position. Wait 5 seconds before attempting to restart unit to allow switch to reset

HOW TO START YOUR UNIT



WARNING: The trimmer head will turn while starting the engine. Avoid any contact with the muffler. A hot muffler can cause serious burns.

COLD ENGINE STARTING (or a warm engine after running out of fuel)

- Set unit on a flat surface.
- Slowly press the primer bulb 6 times.
 Move choke lever to FULL CHOKE position.
- Squeeze the throttle trigger fully and hold through all remaining steps.
- Pull starter rope handle sharply 6 times. Move choke lever to HALF CHOKE posi-
- · Pull starter rope handle no more than 6 pulls, until engine runs.
- Allow engine to run 10 seconds, then move choke lever to OFF CHOKE position.

STARTING A WARM ENGINE

- Move choke lever to OFF CHOKE position.
- Pull starter rope handle until engine runs.

If engine does not start in 5 pulls, follow instructions in STARTING A COLD EN-

USING YOUR UNIT

OPERATING POSITION




Cut from your right to your left.

ADVANCING THE CUTTING LINE

Advance line by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. The metal blade (Line Limiter) attached to the shield will cut the line to the proper length.

REPLACING THE LINE

- · Remove spool by firmly pulling on tap but-
- Clean entire surface of hub and spool.
- Replace with a pre-wound spool, or cut a length of 20 feet of .080" (2 mm) diameter Weed Eater® brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
- Insert one end of the line about 1/2 inch (1 cm) into the small hole on the inside of spool.



- Wind the line evenly and tightly onto the spool. Wind in the direction of the arrow found on the spool.
- Push the line into the notch, leaving 3 to 5 inches (7 - 12 cm) unwound.
- Insert the line into the the exit hole in the hub as shown in the illustration.
- · Align the notch with the line exit hole.
- Push spool into hub until it snaps into place.

- Pull the line extending outside of the hub to release it from the notch.
- Reconnect spark plug lead before starting unit.

SERVICE

We recommend all service and adjustments not listed in this manual be performed by an Authorized Service Dealer.

CARBURETOR ADJUSTMENTS

Your carburetor is equipped with limiter caps. Carburetor adjustment is a complicated task. We recommend that you take your unit to an authorized service dealer. Damage will occur if you turn the needles beyond the limiter stops.

IGNITION TIMING

The ignition timing is fixed, non-adjustable.

SPARK PLUG

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is 0.025".
