INSTALLATION TIPS

The system can be operated freestanding, lying horizontally or mounted vertically

If mounting vertically to a wall, securely connect the mounting bracket to the wall using suitable

Water pressure at the filter system inlet must not exceed II6 psi (8 bar). A pressure reducer valve must be installed on the water supply side of the filter system if the inlet pressure exceeds II6 psi (8 bar)

Shut off valve must be installed upstream of the filter

Refer to Installation, Operation & Maintenance Manual for cartridge flushing and RO start-up

OPERATION TIPS

Change filter cartridges on a regular 6 month preventative maintenance program

Change cartridges when capacity is reached

Always flush the filter cartridge at time of installation and cartridge change

Do not use hardness test strips to check for hardness reduction, please use Titration kit to check for hardness reduction

APPLICATION/SIZING

The CLARIS filter systems are typically used to feed the following appliances:

- -Coffee and Esopresso Machines
- -Hot drink vending machines
- Combi steamers and self-cooking systems
- -Steam cookers and ovens
- -Brewed Iced Tea

The systems can be operated horizontally or vertically, depending on the space available


