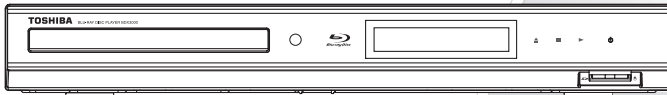

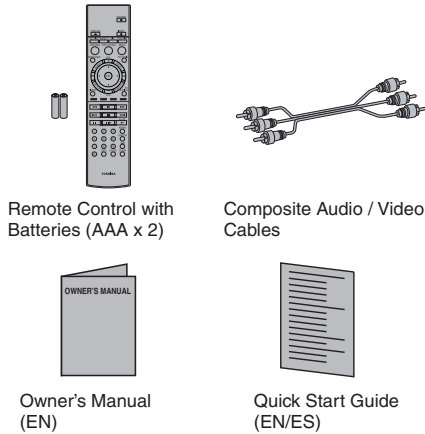

INTRODUCTION

## Features

### Blu-ray Disc

You can enjoy Blu-ray Disc which is capable of storing five times more data than a conventional DVD.

### BD-Java

With some BDs which support Java applications, you can enjoy the interactive functions such as games or interactive menus.

### BD-Live

BD-Live (BD-ROM version 2 Profile 2.0) that allows interactive functions to be used when this unit is connected to the Internet in addition to the BONUSVIEW function. The various functions differ depending on the disc.

### Full high-definition video playback

Watch movies in the highest picture quality available for your HDTV. This unit offers full high-definition video playback up to 1080p resolution for an amazing viewing experience. A highly detailed picture and increased sharpness delivers a more true-to-life picture.

### DVD Upconversion for enhanced picture quality

Your current DVD will look even better than before thanks to video upconversion. Upconversion will increase the resolution of standard definition DVD to high definition up to 1080p over an HDMI connection. The picture will be less jagged and more realistic for a near high-definition experience.

### Enjoy your content on different kinds of media

Full backwards compatibility with BD, DVD, CD and SD card ensures that you can continue to enjoy your current audio-video collection. Additionally, you can view JPEG digital pictures or listen to MP3 or Windows Media™ Audio music files.

### Experience rich multi-channel surround sound

Multi-channel surround sound, which recognizes real-to-life sound and makes you feel like you are really there.

### PIP (BONUSVIEW)

Some BD-videos have the PIP function which enables you to display the secondary video in the primary video. You can call up the secondary video by pressing **BONUSVIEW** whenever the scene contains the secondary video.

### Pop-up menu

Some BD-video have pop-up menu which is a navigation menu that can be called up and be operated on the TV screen without interrupting the playback. You can call up the pop-up menu by pressing **POPUP/TOP MENU** or **MENU**. Contents in the pop-up menu vary depending on the disc.

### Playback of Content from an SD Memory Card

You can play back MP3 / WMA / JPEG files stored in an SD Memory Card. You can store picture-in-picture commentary, subtitles or other extras for BD-ROM ver. 2 (Profile 2.0 / Profile 1.1) files in an SD Memory Card and play back with the BD-video.

### Playing back AVCHD files

This unit supports playback of AVCHD format files (new format for high definition video camcorders) recorded on disc. Your high definition personal archive is playable in HD quality.

### x.v.Color

This unit supports playback of video contents on discs recorded with "x.v.Color" technology. To watch this video content with the "x.v.Color", a TV or other display device supporting both video image reproduction using the "x.v.Color" standard and capable of manually switching its color setting is required. Please refer to the owner's manual of your display device for further information.

Connect this unit to your HDTV with one single HDMI (High-Definition Multimedia Interface) cable. It is recommended to use a High Speed HDMI Cable for better compatibility. The high definition video output signal will be transferred to your HDTV without conversion to analog signals, so you will get excellent picture and sound quality.

Thanks to other multiple outputs, you can also easily connect to your home theater system or amplifier.

### HDMI CEC (Consumer Electronics Control)

This unit supports HDMI CEC, which allows integrated system control over HDMI and is part of the HDMI standard.

This function may not work properly on some devices.

### HDMI 1080p/24F output (BD only)

This unit is equipped with a feature which can provide the smooth movement in the playback of film originated material with the frame rate of 24 frames per second with progressive scan. (Available only when the TV is connected by an HDMI cable and compatible with 1080p/24F frame input.)

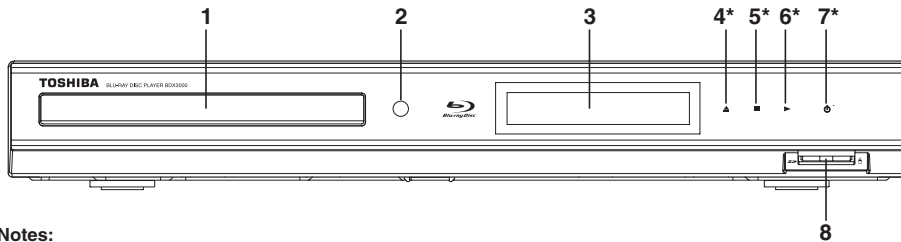
### Copyright protection system

To play back the digital video images of a BD / DVD via an HDMI connection, it is necessary that both the unit and the TV (or an AV amplifier) support a copyright protection system called HDCP (high-bandwidth digital content protection system). HDCP is copy protection technology that comprises data encryption and authentication of the connected AV device. This unit supports HDCP. Please read the operating instructions of your TV (or AV amplifier) for more information.



## Identification of Controls

### Front panel



#### (\*) Notes:

1. These indicators are located in the sensor field.
2. When this unit is off, these indicators are dimmed. If a finger is brought close to the sensor field, the indicators will be invoked and light up.

#### 1. Disc tray

#### 4. OPEN/CLOSE ▲ indicator

- When invoked (white), tap to open/close the disc tray.

#### 5. STOP ■ indicator

- When invoked (white), tap to stop playback.

#### 6. PLAY ► indicator

- When invoked (white), tap to start playback.

#### 7. ON/STANDBY indicator

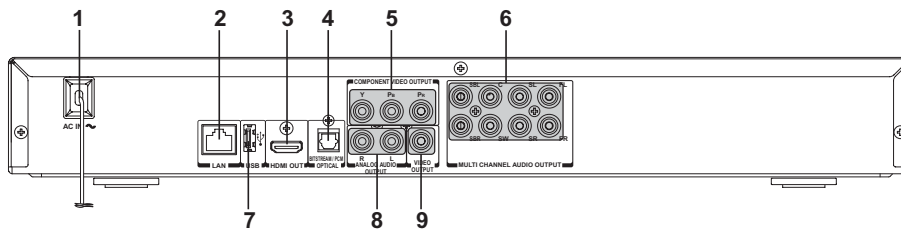
- When invoked (white), tap to turn on the unit, or to turn the unit into the standby mode. (To completely turn off the unit, you must unplug the AC power cord.)

#### 8. SD card slot

#### How to Power On Your Unit ?

1. Connect to a standard AC outlet to supply power to this unit, the **ON/STANDBY** indicator lights in red and then turns white at once.
2. After about 10 seconds, the **ON/STANDBY** indicator will turn red automatically.
3. Touch the **ON/STANDBY** button to turn on the unit. The **ON/STANDBY** indicator will remain white (ON mode).

### Rear panel



#### 1. AC power cord

- Connect to a standard AC outlet to supply power to this unit.
- Unplug this cord from the AC outlet to completely turn off the unit.

#### 2. LAN terminal

- Use to connect a network equipment with LAN cable.

#### 3. HDMI OUT jack

- Use to connect a TV with an HDMI compatible port via an HDMI cable.

#### 4. OPTICAL jack

- Use to connect an AV receiver / amplifier, Dolby Digital / DTS decoder or other device with a digital audio optical input jack using a digital audio optical cable.

#### 5. COMPONENT VIDEO OUT jacks

- Use to connect a TV with component video inputs using a component video cable.

#### 6. MULTI CHANNEL AUDIO OUTPUT jacks

- Use to connect an AV receiver / amplifier with a audio cable.

#### 7. USB jack

- Use to connect USB flash drives (not included).

#### 8. AUDIO OUT jacks

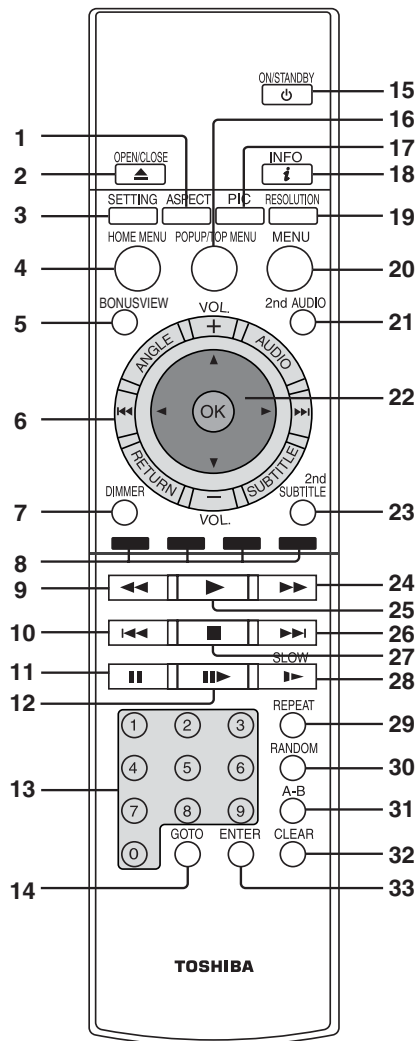

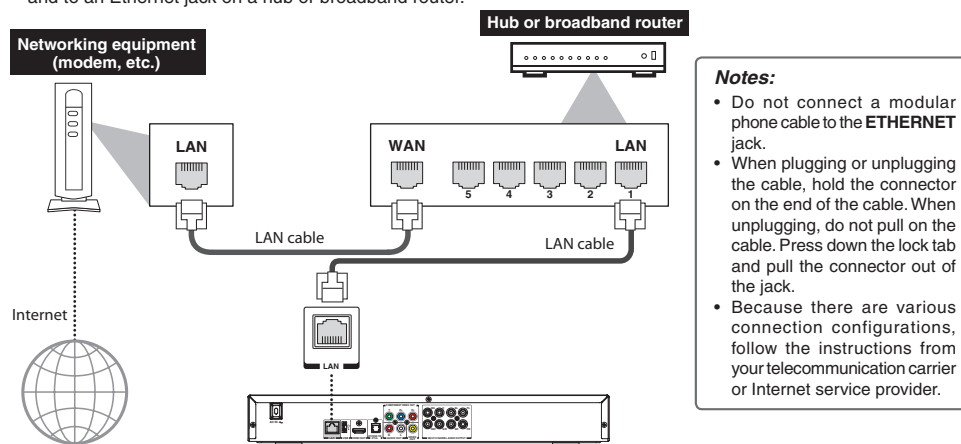
## Network Connection

Your Blu-ray disc player can be connected to your home network:

- By connecting an Ethernet cable to the ETHERNET jack on the rear of your player and to a wired hub or router. Using a wired network provides the best performance, because the attached devices connect directly to the network and are not subject to radio frequency interference.
- By connecting through the built-in wireless device and a wireless access point or router.

### Connecting your player to a wired router:

- Connect an Ethernet cable (CAT5 or better with RJ45 connector) to the ETHERNET jack on the back of your player and to an Ethernet jack on a hub or broadband router.



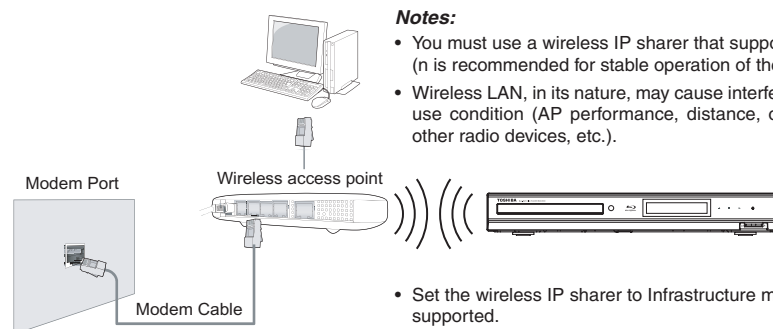
#### Notes:

- Do not connect a modular phone cable to the ETHERNET jack.
- When plugging or unplugging the cable, hold the connector on the end of the cable. When unplugging, do not pull on the cable. Press down the lock tab and pull the connector out of the jack.
- Because there are various connection configurations, follow the instructions from your telecommunication carrier or Internet service provider.

### Connecting your player to a wireless access point or router:

Your Blu-ray disc player has an integrated Wi-Fi device and antenna. No physical connection to the wireless router is necessary.

- Configure your player to access the wireless access point or router. For more information, see "Configuring a wireless Internet connection" on page 36.
- The network configuration and connection method may vary depending on the equipment in use and the network environment. Your Blu-ray disc player is equipped with an IEEE 802.11n wireless module, which also supports the 802.11 a/b/g/n standards. For the best wireless performance, we recommend using an IEEE 802.11n certified Wi-Fi network (access point or wireless router).



#### Notes:

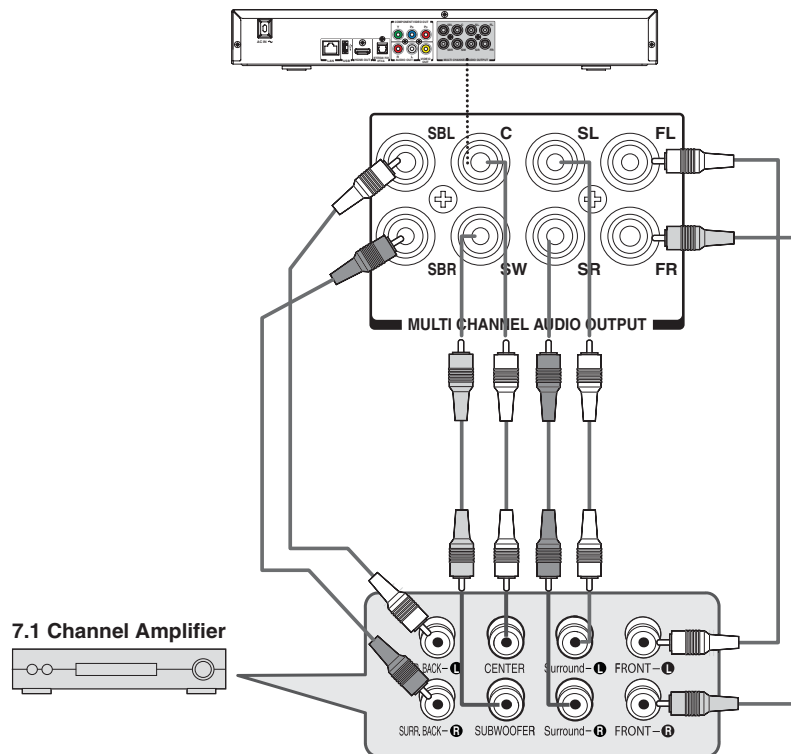
- You must use a wireless IP sharer that supports IEEE 802.11 a/b/g/n. (n is recommended for stable operation of the wireless network.)
- Wireless LAN, in its nature, may cause interference, depending on the use condition (AP performance, distance, obstacle, interference by other radio devices, etc.).

- Set the wireless IP sharer to Infrastructure mode. Ad-hoc mode is not supported.
- When applying the security key for the AP (wireless IP sharer), only the following is supported.
  - 1) Authentication Mode : WPAPSK, WPA2PSK
  - 2) Encryption Type : WEP, TKIP, AES

## Connecting the Speakers (For 7.1 Audio Channel)

You can connect the speakers as shown in the following diagram to obtain the 7.1 audio channels effects. Using the audio cables, connect the **MULTI CHANNEL AUDIO OUTPUT** (SBL, SBR, C, SW, SL, SR, FL & FR) terminals on the rear of the Blu-ray disc player to 7.1 Channel ANALOG AUDIO IN terminals of your Amplifier.

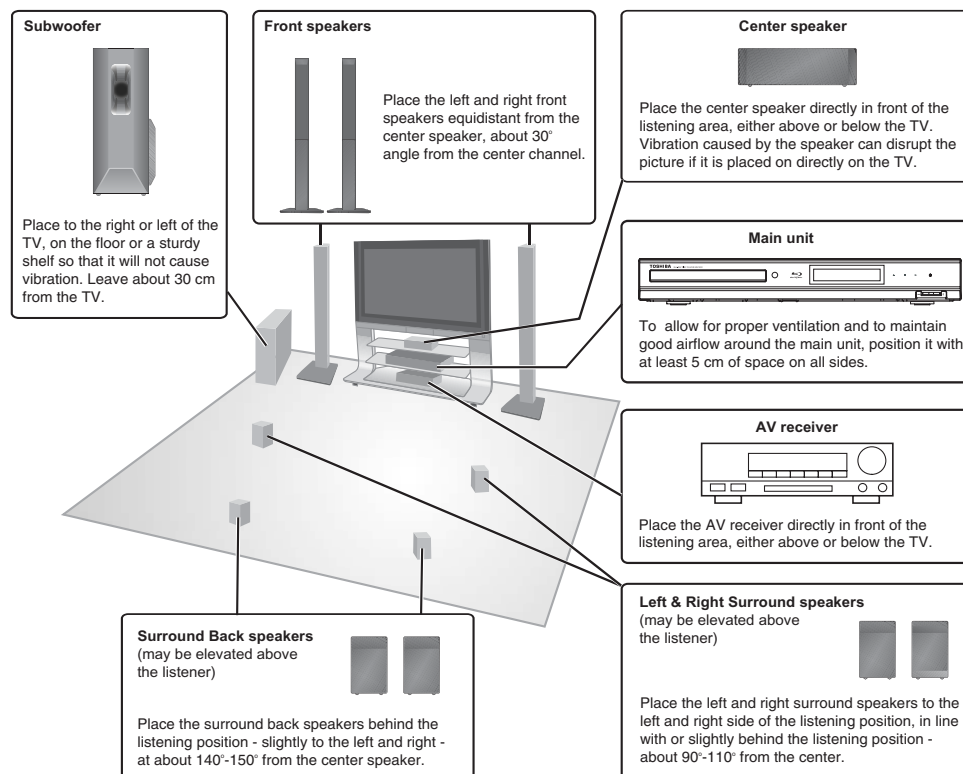

## Positioning the Speakers (For 7.1 Audio Channel)

How you set up your speakers can affect the bass and the sound field. Note the following points:

- Place speakers on flat secure bases.
- Placing speakers too close to floors, walls, and corners can result in excessive bass. Cover walls and windows with thick curtains.
- Keep your speakers at least 10 mm away from the system for proper ventilation.

### Color Systems

BD-video and DVD-video are recorded in different color systems throughout the world. The most common color system is NTSC (which is used primarily in the United States and Canada).

### Region Codes

This unit has been designed to play back BD-video with region "A" and DVD-video with region "1" or "ALL". You cannot play back BD-video or DVD-video that are labeled for other regions. Look for the symbols on the right on your BD-video or DVD-video.

If these region symbols do not appear on your BD-video or DVD-video, you cannot play back the disc in this unit. The letter or number inside the globe refers to region of the world. A BD-video or DVD-video labeled for a specific region can only be played back in the unit with the same region code.



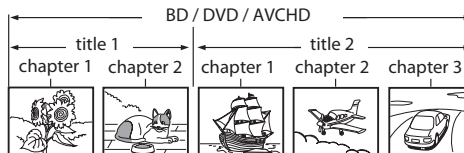

### Structure of Disc/SD Card Contents

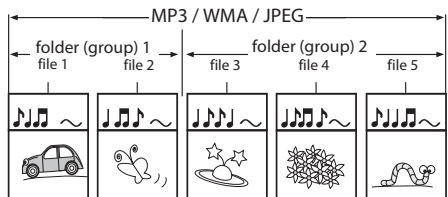
The contents of BD / DVD / AVCHD are generally divided into titles. Titles may be further subdivided into chapters.



Audio CD is divided into tracks.



Data discs, USB device, SD Memory Cards containing MP3 / WMA / JPEG are divided into folders, and the folders are subdivided into files.





## Playing a Disc

This section shows you the basics on how to play a disc.

### CAUTION:

Keep your fingers well clear of the disc tray as it is closing. Neglecting to do so may cause serious personal injury.

## Basic playback

### Preparations

- When you want to view a disc, turn on the TV and select the video input connected to the Blu-ray disc player.

### 1 Press the ON/STANDBY button.



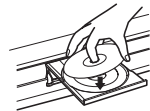
The Blu-ray disc player turns on.

### 2 Press OPEN/CLOSE.



The disc tray opens.

### 3 Place the disc on the disc tray.



With the playback side down

### 4 Press OPEN/CLOSE to close the disc tray.



Playback starts.

If you insert a Blu-ray disc or a DVD that contains a top menu, a menu may appear. Use **▼/▲/◀/▶** to select the title you want to view, then press **OK** to start playback.

- You may need to press the **POPUP/TOP MENU** or **MENU** button to display disc menu (depending on the actual Blu-ray disc or DVD.)

### ■ To start playback in the stop mode

Press **▶ PLAY**.

### ■ To pause playback (still mode)

Press **⏸ PAUSE** during playback.

To resume normal playback, press the **▶ PLAY** button.

- The sound is muted during still mode.

### ■ To stop playback

Press **■ STOP**. The home menu is displayed.

For Blu-ray discs, press **▼/▲** to select BD-ROM, then press **OK** to start playback at the beginning of the disc.

For DVDs/audio CDs, press **▶ PLAY** to resume normal playback.

- Depending on the disc, playback starts where it stopped or at the beginning of the disc.

- If you press **■ STOP** twice, playback stops completely. To start playback again, press **▶ PLAY**. Playback starts at the beginning of the disc.

### ■ To remove the disc

Press **OPEN/CLOSE**.



Remove the disc after the disc tray opens completely.

Be sure to press the **OPEN/CLOSE** button to close the disc tray after you remove the disc.

### ■ To turn the power off

Press **ON/STANDBY** button to turn the unit off.

## Variable Speed Playback

You can play discs at various speeds, and resume playback from the location where you stopped playback.

### Playing in fast reverse / forward directions

Press ◀◀ or ▶▶ during playback.

▶▶ : Fast forward playback

◀◀ : Fast reverse playback

Each time you press this button, the fast-forward or fast-reverse speed changes in the following sequence:

Fast x 2 → Fast x 4 → Fast x 8 → Fast x 16  
→ Fast x 32 → Fast x 64 → Fast x 128.

■ To resume normal playback

Press ▶ PLAY.

Notes:

- The Blu-ray disc player mutes sound and subtitles during reverse and forward scan.
- The playback speed may differ depending on the disc.

### Playing frame by frame

Press ■▶ during still playback.



Each time you press this button, the picture advances one frame.

■ To resume normal playback

Press ▶ PLAY.

Note: The sound is muted during frame by frame playback.

### Playing in slow motion

Press ■▶ during playback.



Each time you press this button, the slow-motion speed changes in the following sequence:

Slow x 1/2 → Slow x 1/4 → Slow x 1/8

■ To resume normal playback

Press ▶ PLAY.

Notes:

- The sound is muted during slow-motion playback.
- 3 speeds are available.

## Locating a Desired Section

Normally, Blu-ray discs and DVDs are divided into titles, and the titles are sub-divided into chapters. Audio CDs are divided into tracks. You can quickly locate any specific title, chapter, or track.

### Locating a title using the top menu

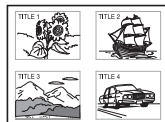
**1** Press POPUP/TOP MENU.

The top menu appears on the TV screen.

**2** Press ▼ / ▲ / ◀ / ▶ to select the title you want.

If the titles in the top menu are assigned a number, you can directly locate a specific title by pressing its designated number with the number buttons.

Press **◀▶** or **▶▶** repeatedly to access the chapter or track number you want.

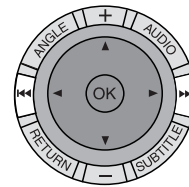

You can also press **◀▶** or **▶▶** (shown as in the right illustration) on the remote control to access the desired chapter or track.

- The chapter, title or track repeat will be cleared when moving to another chapter, title, track / file or folder.
- Repeat playback does not function during A-B repeat playback.
- Chapter and title repeat are not available with some scenes.
- When the repeat setting is set for a MP3 or WMA folder (file), the repeat setting will be cancelled if you select other MP3 or WMA folder (file) to playback.

### Repeating a specific segment

**1** Press A-B at the desired starting point A during playback.



**2** Press A-B at the desired ending point B during playback.



The BD player automatically returns to point A and starts repeat playback of the selected segment (A-B).

#### ■ To resume normal playback

Press A-B until  is displayed.

**Start Slide Show:** This option enables you to view picture (files) one after another automatically.  
**Browse Music:** Goes back to Music folder.

**5 To stop playing and return to the main menu, follow one of the steps described below:**

- Press **STOP**.
- Press **RETURN**.
- Press **◀**, then use **▼ / ▲** to highlight Main Menu and then press **OK** to confirm.

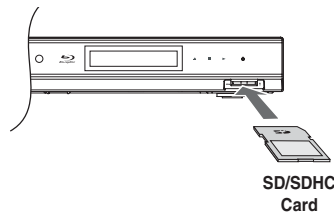

## Inserting an SD card

- 1** Inserting an SD card fully into the slot on the front of Blu-ray disc player until it clicks as illustrated.



- 2** Press **▼ / ▲** to select Music or Pictures, and then press **OK**.

If no USB device or optical disc containing music or pictures is inserted, the system will directly load the data on the inserted SD card. Otherwise, it will enter the source selection screen. If so, please follow the operation instructions in **“Playing files on a data disc”** on page 25 for details.

### ■ To pause playback

Press **||** during playback. To resume normal playback, press **▶ PLAY**.

### ■ To stop playback

Press **■ STOP**.

### ■ Removing the SD card

In stop mode, gently push the SD card into the slot and then pull it out slowly.

- If you cannot easily insert the memory card, you may have inserted it incorrectly. Try to turnover the card and then insert again. Do not force the memory card into the memory card slot.
- Do not remove the SD card during playback.



## Using a USB Device

You can play MP3, WMA or JPEG files that have been stored on USB devices on the Blu-ray disc player.

### Operating a USB device

**1** Inserting a USB device into the USB slot on the back of Blu-ray disc player until it clicks.

**2** Press **▼ / ▲** to select Video, Music or Pictures, and then press **OK**.

If no optical disc or SD card containing music or pictures is inserted, the system will directly load the data on the USB device. Otherwise, it will enter the source selection screen. If so, please follow the operation instructions in "Playing files on a data disc" on page 25 for details.

■ **To pause playback**

Press **II** during playback. To resume normal playback, press **▶ PLAY**.

■ **To stop playback**

Press **■ STOP**.

■ **Removing the USB device**

In stop mode, gently pull the USB device out slowly.

**Notes:**

- If you cannot easily insert the USB device, you may have inserted it incorrectly. Try to turnover the device and then insert again.
- Do not remove the USB device during playback.

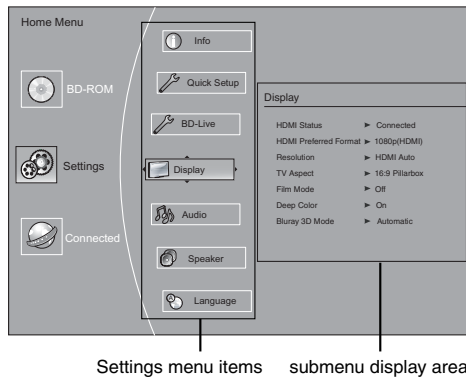

## Customizing the Function Settings

You can change the default settings to customize performance to your preference.

### General Operations

1. Press **▼ / ▲** to select **Settings** in home menu while in full stop mode, the Settings menu appears.
2. Press **▶** button, then use **▲ / ▼** button to select the setting options.
3. Press **OK** button.
4. Press **◀** or **RETURN** button to return to the previous menu.



3. Follow the on-screen instructions to customize the following settings to your preference:

- **OSD Language Settings**
- **Resolution**
- **TV Aspect**
- **Wireless**
- **Optical Disc Auto Play**
- **Screen Saver Duration**

4. After setting, press **OK** to confirm and exit the setup.

**Note:** If it is the first time for the player to start up or users restore all settings to factory defaults, the system will prompt you to perform Quick Setup. Repeat the steps described as above to complete the setup.

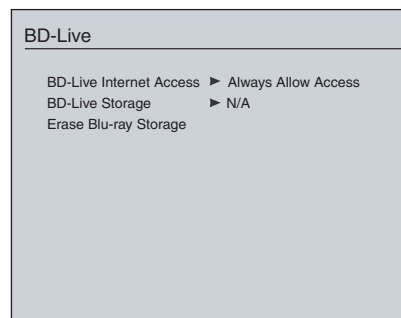
### Using BD-Live™ Features

Some (but not all) BD discs contain additional features that are made available to players that are connected to the internet, and have additional memory added. These additional features may include things like:

- the ability to download new movie trailers
- additional 'commentary' by actors and directors
- multiplayer game play and chat

In order to access BD-Live functions, the player must be properly configured for BD-Live internet access, and it must be equipped with additional memory.

1. In the main menu of **Settings**, press **▶** button, then use **▲ / ▼** button to select **BD-Live**, then press **OK**.



2. Press **▲ / ▼** to select an option, and then press **OK**.
3. Use **▲ / ▼** to select the desired setting, and then press **OK** to confirm.
4. Press **◀** to go to the previous menu.

### Info Menu

This submenu displays the following information:

- **Software Version**
- **Software Date**
- **Netflix ESN**

1. In the main menu of **Settings**, press **▶** button, then use **▲ / ▼** button to select **Info** to display the software version, software date and Netflix ESN.
2. Press **◀** or **RETURN** to go to the previous menu.

### Performing Quick-Setup

1. In the main menu of **Settings**, press **▶** button, then use **▲ / ▼** button to select **Quick Setup**, and then press **OK** to confirm.

2. Press **OK** to perform Quick Setup.

To exit the setup menu:

- Use **▼** button to highlight "No thanks. I'll go through the full setup menu later", and then press **OK**.
- Or press **◀** button directly.

## Customizing the Function Settings

### BD-Live Internet Access:

- **Limit Access** — Allows Internet access with valid “BD-Live” network access approval.
- **Always Allow Access** — Always allows BD-Live Internet access.
- **Prohibit Access** — Never allows BD-Live Internet access.

In order to set the player up for BD-Live Internet Access, perform the following steps:

1. In the main menu of **Settings**, press ► button, then use ▲ / ▼ to select **BD-Live**, then press **OK**.
2. Press ▲ / ▼ to select “**BD-Live Internet Access**”, and then press **OK**.
3. Use ▲ / ▼ to select the desired setting, and then press **OK** to confirm.
4. Make sure that “**Limit Access**” or “**Always Allow Access**” is checked.
5. Once the USB device or SD card has been inserted, if there is not at least 100Mbyte of free space on the device, you should choose “**Erase Blu-ray Storage**” from the BD-Live setup menu.
6. Press ◀ to return to the main menu of **Settings**, then use ▲ / ▼ to highlight **Network**, and then press **OK**. (For details, please refer to “Network Connection Setting” on Page 36.)

### Notes:

- Depending on your connection environment, it may take time to connect to the Internet or the Internet may not be connected.
- When BD-Live function are used and the unit is connected to the Internet, you may be charged for this communication.
- Do not remove the USB device or SD card when using the BD-Live function.

### BD-Live Storage:

This option is used to tell the BD player whether or not to use an inserted SD card or USB device to store BD-Live content (movie trailers, additional scenes, etc.).

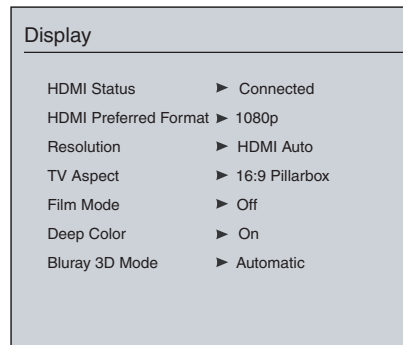
In order to add BD-Live memory for BD-Live Internet Access, insert an USB device or SD card (1GB is recommended) into the USB slot or SD card slot on the player.

### Erase Blu-ray Storage:

If you choose **OK** to erase Blu-ray storage, all bookmarks and BD-Live content saved in memory are deleted.

## Display Setting

1. In the main menu of **Settings**, press ► button to select **Display**, and then press **OK** to confirm.
2. Press ▲ / ▼ to select an option, and then press **OK**.
3. Use ▲ / ▼ to select the desired option, and then press **OK** to confirm your selection.
4. Press ◀ to go to the previous menu.



### HDMI Status:

This option displays the HDMI status. If an HDMI TV is connected, **Connected** appears. If an HDMI TV is not connected, **Disconnected** appears.

### HDMI Preferred Format:

This option shows the best HDMI format for the connected TV.

### Resolution:

You can define the video output resolution in this option. In case that the menu of “Resolution” setting disappears, make composite video (yellow) connection to restore it, then select the resolution which is compatible with the connected TV.

### Notes:

- Selecting a resolution the TV does not support could result in an unstable picture or loss of the picture. See the documentation that came with the TV to find the resolutions the TV supports.
- Only the HDMI output on your player supports 1080p video output at any frame rate. If the TV is connected to the component output, the video output is limited to 1080i or lower.

## Customizing the Function Settings

TV Type	Resolution
If your TV is a high-definition TV (HDTV) connected to the HDMI jack on your player and you want your player to set the output resolution based on information exchanged between the TV and your player over the HDMI cable.	HDMI Auto
If the TV is a high-definition TV (HDTV) capable of 1080p (any frame rate) connected to the HDMI jack on your player	1080p
If your TV is a high-definition TV (HDTV) capable of 1080i only	1080i
If your TV is a high-definition TV (HDTV) capable of 720p only	720p
If your TV is an enhanced-definition TV (EDTV)	480p
If your TV is a standard-definition NTSC TV (American or Asian SD TV)	480i

### TV Aspect:

Depending on the type of television you have, you may want to adjust the screen setting.

- **16:9 wide** — You can view the full 16:9 picture on your widescreen TV.
- **16:9 Pillarbox** — Movie will be displayed in the center of the screen and vertical bars will appear on sides of the screen.
- **4:3 Pan and Scan** — Select when you want to see the 16:9 video supplied by the Blu-ray Disc/DVD without the black bars on top and bottom, even though you have a TV with a 4:3 ratio screen. The extreme left and right portion of the movie picture will be cut off.
- **4:3 Letterbox** — Select when you want to see full 16:9 ratio image supplied by a Blu-ray Disc/DVD, even though you have a TV with a 4:3 ratio screen. Black bars will appear at the top and bottom of the screen.

### Notes:

- Depending on the disc type, some aspect ratios may not be available.
- If you select an aspect ratio and option which is different from the aspect ratio of your TV screen, the picture might appear distorted.

### Film Mode:

Movies are recorded on film at a rate of 24 pictures (frames) per second. Many of the movies on Blu-ray discs are placed on the discs at this frame rate. If your TV supports 24 frames per second, but you would prefer viewing the video at a higher frame rate, you should turn off Film Mode. **Off** selects a 60 frames/second output format.

### Deep Color:

This option decides whether to turn off the Deep Color (color depth) setting for video signals output from the HDMI OUT jack.

Connecting the player and a TV that supports Deep Color allows more accurate color reproduction than when connecting it to a TV that does not support Deep Color. It is recommended to set this option **Off** if the picture is unstable or colors appear unnatural.

### Bluray 3D Mode:

Select whether to play a Blu-ray Disc with 3D contents in 3D Mode.

**Automatic:** The 3D Blu-ray disc is played in 3D mode if your product detects a TV which supports it. It is played in 2D mode if your product detects a TV which can not support it.

**Forced 2D:** The 3D Blu-ray disc is played in 2D mode at all times. Select this option to view a picture without 3D effect or when a TV cannot support 3D Blu-ray discs.

### Notes:

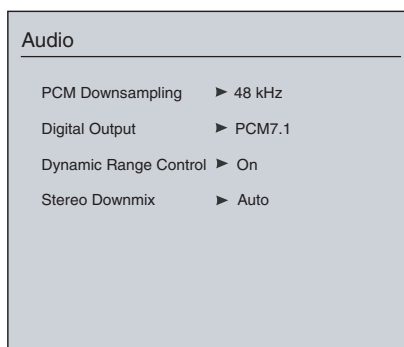
- If you or any viewer experiences the following symptoms or any other discomfort from viewing 3D video images, stop viewing and contact your health care provider:  
Convulsions, Eye or muscle twitching, Loss of awareness, Altered vision, Involuntary movements, Disorientation, Eye Strain, Nausea/Vomiting, Dizziness, Headaches or Fatigue
- Carefully read instructions provided with your display and/or 3D glasses before 3D viewing.
- If you want to enjoy a 3D content, connect a 3D device (3D compliant AV receiver or TV) to the product and wear a 3D glass before playing the 3D content.
- While watching the 3D video, all analogue component and composite signals will be blocked automatically.
- All 3D signals are output only using the HDMI cable and through the HDMI OUT port.
- As the video resolution in 3D play mode is fixed according to the resolution of the original 3D video, you can not change the resolution to your preference.
- You must use a high-speed HDMI cable for a proper output of the 3D signal.
- You can not use this product for switching a 2D content to 3D.

## Customizing the Function Settings

### Audio Setting

The settings in the Audio menu will configure the BD player's digital audio outputs (**HDMI** or **Optical**).

1. In the main menu of **Settings**, press ► button, then use ▲ / ▼ button to select **Audio**, then press **OK** button.



2. Press ▲ / ▼ to select an option, and then press **OK**.
3. Use ▲ / ▼ to select your preferred audio items, and then press **OK** to confirm your selection.
4. Press ◀ to go to the previous menu.

#### PCM Downsampling:

**If you don't have a surround sound receiver connected to the BD player**, you should **leave the PCM downsampling to 48 kHz**, and proceed to the next setup menu item. This is true regardless of whether the audio is connected to the TV with HDMI or the analog stereo outputs.

**If you have a surround sound receiver connected to the BD player, and you have connected to the surround receiver via the BD player's analog multichannel audio outputs**, this setting has no effect on the audio going to the analog outputs of the player. Leave the PCM downsampling to 48 kHz, and proceed to the next setup menu item.

**If you have a surround sound receiver connected to the BD player, and you have connected to the surround receiver via the BD player's HDMI output**, this setting has no effect on the audio going to the HDMI output of the player. **Leave the PCM downsampling to 48 kHz**, and proceed to the next setup menu item.

**If you have a surround sound receiver connected to the BD player via optical cable**, set this menu item to the maximum PCM sampling rate that your surround receiver can accept (48 kHz or 96 kHz). **If in doubt, consult your surround receiver's manual or set to 48 kHz.**

**Note:** Incorrectly setting the digital audio output's PCM sampling rate too high may result in unpredictable audio playback.

#### Digital Output:

- **PCM Stereo** — Sets the output to PCM Stereo if you have not an audio receiver connected to your Blu-ray disc player or the audio receiver connected to Blu-ray disc player is not a 5.1/7.1 channel receiver.
- **Bitstream HD** — Lets your player send Dolby TrueHD or DTS-HD MA bitstreams over HDMI (if your player is connected to a compatible HDMI audio receiver). If your player is not connected to a compatible HDMI receiver (for example, your player is connected directly to the TV or your player is connected to an audio receiver using an optical cable), a compatible audio signal is automatically sent over the HDMI and optical connections. With this setting, Blu-ray audio is limited to the soundtrack for the main movie (no PIP audio).
- **Bitstream Legacy** — Sends a DTS or Dolby Digital bitstream from the disc over the HDMI and optical connections. Blu-ray audio is limited to the soundtrack for the main movie (no PIP audio).
- **Bitstream Mixed** — Sends a mixed (PIP audio and movie audio) DTS audio stream over the HDMI and optical connections. This mode is primarily intended for use when you want to hear both PIP audio and the movie audio.
- **PCM 5.1** — Sends a PCM audio signal of up to 5.1 channels over the HDMI connection and up to 2 channels over the optical connection.
- **PCM 7.1** — Sends a PCM audio signal of up to 7.1 channels over the HDMI connection and up to 2 channels over the optical connection.

#### Dynamic Range Control:

**Dynamic Range Control** means that you can allow the BD player to make the loud parts of a movie's audio track quieter than they would be in the theatre, without making the dialog of the actors any quieter.

This would be useful, for instance, when you want to watch a movie in the evening when others might be sleeping.

**Notes:** This setup menu item **has no effect** unless:

- The device playing the disc's audio (TV or surround audio receiver) is connected to the BD player's analog audio outputs; OR
- you have selected "Bitstream Mixed" in the BD player's audio setup menu.

When **Dynamic Range Control** is set to **Off**, movie soundtracks are played with the standard dynamic range.

When movie soundtracks are played at low volume or from smaller speakers, you can set **Dynamic Range Control** to **On**. Your player applies appropriate compression to make low-level content more intelligible and prevent dramatic passages from getting too loud.

## Customizing the Function Settings

Selecting the "Auto" option turns on the Dynamic Range Control for all BD movie soundtracks except Dolby TruHD. If you have selected a TruHD track on the BD disc, the "auto" selection tells the BD player to only turn on dynamic range control if information embedded in the TruHD sound track tells it to do so.

### Stereo Downmix:

Select whether to downmix the multi-channel audio into fewer channels.

- **Auto** — Downmixes the multi-channel audio into the specific stereo that the connected equipment supports.
- **Stereo (LoRo)** — Downmixes the multi-channel audio into two channel stereo. Choose when the Blu-ray disc player is connected to the equipment that does not support virtual surround function such as Dolby Pro Logic.
- **Surround Encoded (LtRt)** — Downmixes the multi-channel audio into surround compatible stereo. Choose when the Blu-ray disc player is connected to the equipment that supports virtual surround function such as Dolby Pro Logic.

### Speaker Setting

Once the speakers are connected to the system and properly configured, you can check to verify that the connections to the speakers are correct by running an audio speaker test.

To run this test, follow the instructions described as below:

1. In the main menu of **Settings**, press **▶** button, then use **▲/▼** button to select **Speaker**, then press **OK**.

**Note:** This setup menu item has no effect unless:

- If you have selected 'Bitstream Mixed' in the audio menu, these menu choices will have no effect. (Each channel's full audio spectrum will be sent to each speaker, regardless of the speaker size selected)
  - If you don't know the type of speakers attached to your surround sound system, consult the manual for your speaker system.
2. Use **▼/▲/▶/◀** to highlight the desired speaker, then press **OK** to enter.
  3. Press **▼/▲** to choose the desired audio signal, and then press **OK** to confirm.

### Front Left & Right Speakers:

- By setting the front left speaker's size, the front right speaker's size is automatically changed to match.
- The front speakers can not be turned off. They can only be set to 'Small' or 'Large'.

### Center Speaker:

- If the front speakers have been set to small, the center speaker can only be set to 'Small' or 'Off'.
- Setting a speaker to 'off' will result in no sound being delivered to that speaker.

### Subwoofer:

- If you don't know the crossover frequency of your subwoofer, consult the manual for your speaker system.

### Surround Left & Right Speakers:

- By setting the left surround speaker's size, the right surround speaker's size is automatically changed to match.
- If the front speakers have been set to small, the surround speakers can only be set to 'Small' or 'Off'.

### Rear Left & Right Speakers:

- By setting the left rear speaker's size, the right rear speaker's size is automatically changed to match.
- If the front speakers have been set to small, the rear speakers can only be set to 'Small' or 'Off'.

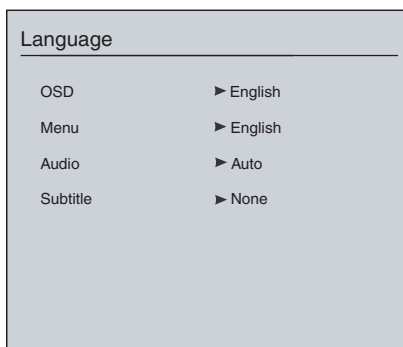
4. Use **▼/▲/▶/◀** to move the highlight box to the **Test** button on the bottom, then press **OK**. A message will appear.
5. Press **▼/▲** to choose the desired audio signal. You can select between Pink, 1kHz Sine and White.
6. Press **OK** to begin the speaker test. The audio signal will be sent to a different speaker every approximately every two seconds. The audio test will highlight which speaker is supposed to be getting the sound on the screen.
7. To stop the audio test, press one of the **▼/▲/▶/◀** buttons.
8. Press **◀** or **RETURN** to go to the previous menu.



## Customizing the Function Settings

### Language Setting

1. In the main menu of **Settings**, press **▲ / ▼** to select **Language**, and then press **OK**.



2. Press **▲ / ▼** to select **OSD**, **Menu**, **Audio** or **Subtitle**, and then press **OK**.
3. Use **▲ / ▼** to select your preferred language, and then press **OK** to confirm your selection.
4. Press **◀** to go to the previous menu.

#### OSD:

This option enables you to select the on-screen menu language.

#### Menu:

This option lets you to select the disc menu language.

#### Notes:

- Not all languages are available on all discs.
- Most discs only have one menu language.

#### Audio:

You can choose the audio language from this option to your preference.

#### Notes:

- Not all languages are available on all discs.
- Some discs do not let you select the audio language using your player's menu. Instead, you have to select the audio language from the disc setup menu (the menu that appears after you insert the disc).

#### Subtitle:

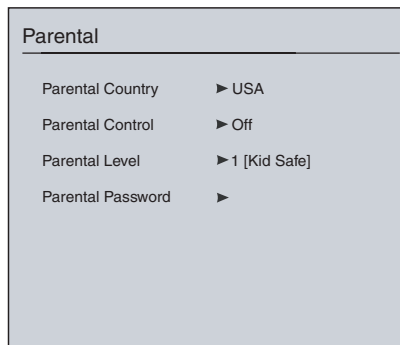
You can customize your preferred subtitle language in this option.

#### Notes:

- Not all languages are available on all discs.
- Some discs do not let you select the subtitle language using your player's menu. Instead, you have to select the subtitle language from the disc setup menu (the menu that appears after you insert the disc).
- You can also select the subtitle language from the subtitle menu in the on-screen menu.

### Parental Control

1. In the main menu of **Settings**, press **▶**, then press **▲ / ▼** to select **Parental**, and then press **OK**.



2. Press **▲ / ▼** to select **an option**, and then press **OK**.
3. Use **▲ / ▼** to select the desired option, and then press **OK** to confirm your selection.
4. Press **◀** to go to the previous menu.

**Note:** If **Parental Control** was previously turned **On**, you will be prompted to enter the parental control password before being allowed to change these settings. (See "Turning parental control on or off" on page 34 for details.)

#### Selecting the parental country

Parental Country is fixed in USA.

#### Turning parental control on or off

1. In the main menu of **Settings**, press **▶**, then press **▲ / ▼** to select **Parental**, and then press **OK**.
2. Press **▲ / ▼** to select **Parental Control**, then press **OK**.
3. Press **▲ / ▼** to select **On** or **Off**, then press **OK**.
4. Press **◀** to go to the previous menu.

### Setting the parental control level

  - **3 [PG]** — Parental guidance suggested.
  - **4 [PG-13]** — Not suitable for anyone under 13.
  - **5 [PG-R]** — Parental guidance recommended.
  - **6 [R]** — Not suitable for anyone under 17 unless supervised by a parent or adult guardian.
  - **7 [NC-17]** — Not suitable for anyone under 17.
  - **8 [Adult]** — All BDs and DVDs can be played.
4. Press **◀** to go to the previous menu.

### Setting the parental control password

1. In the main menu of **Settings**, press **►**, then press **▲ / ▼** to select **Parental**, and then press **OK**.
2. Press **▲ / ▼** to select **Parental Password**, then press **OK**.
3. Enter a 4-digit number for the parental password, then use **▼** to highlight **Ok**, and then press **OK** to confirm.  
If you forget your password, reset your player to the factory defaults. For more information, see "**Restore factory defaults**" on page 35.
4. Press **◀** to go to the previous menu.

### System Setting

1. In the main menu of **Settings**, press **►** button, then use **▲ / ▼** button to select **System**, then press **OK**.

2. Press **▲ / ▼** to select an option, and then press **OK**.

#### Optical Disc Auto Play:

If **Enable** is selected, it will load data and play back automatically when you insert a Blu-ray disc. When **Disable** is selected and if you insert a Blu-ray disc, the disc you can select will be displayed on the Settings menu.

#### Time Zone:

This option allows you to select the desired time zone.

#### Screen Saver Duration:

This Blu-ray disc player has a screen saver feature that turns the screen black when your player is inactive. You can set the interval time you want your player to wait before activating the screen saver.

**Note:** The unit shuts down automatically in about thirty minutes if it remains idle and no activities are made.

#### CEC Support:

This option is used to allow the TV remote control to control certain functions of the Blu-ray disc player; and for the Blu-ray player to control certain functions of the TV.

**On:** Allow mutual control of devices through HDMI.

**Off:** Do not allow CEC control.

#### Notes:

- Not all TVs are compatible with your Blu-ray disc player.
- The default setting is **Off**. Select **On** if CEC control is necessary.

### **Update Via Network:**

This option displays the required storage space if the BD player is connected to internet for upgrade.  
For detailed upgrade operation, please refer to “**Upgrading Your Player’s Firmware**” on this page.

### **Restore factory defaults:**

Choose one of the following 7 options, then press **OK** to pop up a dialog box, choose **OK** in the box, and then press **OK** to confirm.

To apply the deactivation, please plug off the player after operating deactivation.

## *Upgrading Your Player’s Firmware*

The company that produced this player may occasionally offer upgrades to the player’s software.

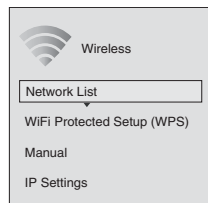
### **Automatic upgrades over the Internet**

1. Make sure that your player is successfully connected to the Internet. If new software is available, you will see a message prompting you whether to update your firmware.
2. If you want to update the player’s firmware, use **▶** / **◀** to highlight “OK”, and then press **OK**. The software will begin downloading, and a status bar will appear on the TV screen.
3. Once the update is complete, a message will appear indicating that the player will turn itself off and on.

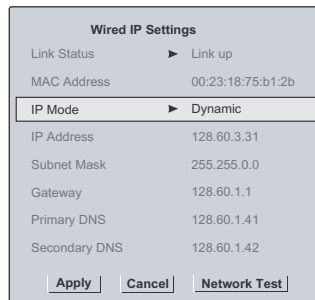
### Network Connection Setting

- Press  $\blacktriangledown$  /  $\blacktriangle$  to select **Network** in stop mode, then press  $\blacktriangleright$  button,
- If no Ethernet cable is connected to the ETHERNET jack on the back of your player, a screen similar to the following appears:



For detailed operations, refer to the “**Configuring a wireless Internet connection**”.

- If a wired connection is made to your player, a screen similar to the following appears:



Refer to the “**Configuring a wired Internet connection**” for details.

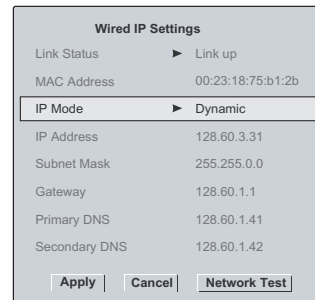
- “Wireless” and “Wired” are optional and do not appear at the same time. Normally, “Wireless” is shown without wired connection. While using a wired Internet connection, “Wireless” is disabled and “Wired” is activated.

### Configuring a wired Internet connection

- Press  $\blacktriangledown$  /  $\blacktriangle$  to select **Network** in stop mode, then press  $\blacktriangleright$  button to enter the following screen:

If the network connection is active, **Link Up** appears next to Link Status. If the network connection is not active, **Link Down** displays next to Link Status.

- Press  $\blacktriangledown$  /  $\blacktriangle$  to select **IP Mode**, then press **OK**.



- Press  $\blacktriangledown$  /  $\blacktriangle$  to select an IP mode. You can select:
  - Off** — Disables the network interface.
  - Manual** — Lets you manually configure network settings, such as IP address, subnet mask, and gateway settings.
  - Dynamic** — Uses DHCP to automatically obtain an IP address.
- Press  $\blacktriangledown$  /  $\blacktriangle$  /  $\blacktriangleright$  /  $\blacktriangleleft$  to highlight **Network Test**, and press **OK** to test your network connection.
- Press  $\blacktriangleleft$  or **RETURN** to go to the previous menu.

### Configuring a wireless Internet connection

This section describes how to configure the BD player for accessing the internet via a WiFi connection. The procedure for connecting to a wireless network depends on various network parameters. 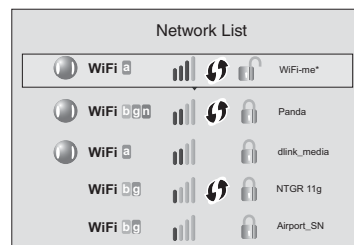

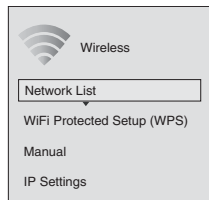

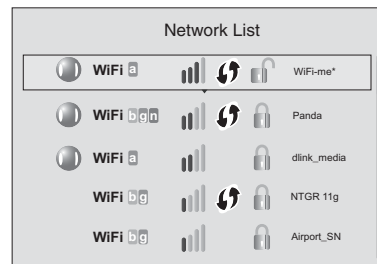

### I. Connection to the wireless Network which you select

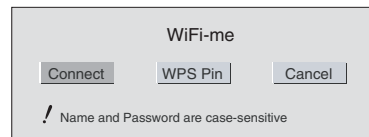


- In the "Wireless" menu, press **▼ / ▲** to select **Network List**, then press **OK**. A list of existing wireless networks near the BD player will appear (It may take several seconds for this list to be created). For example:



- Press **▼ / ▲** to select the desired wireless network, and press **OK** to confirm.

- If the BD player is connected to an **Unencrypted Wireless Network**, a menu similar to the following will appear:



- Press **◀ / ▶** to highlight **Connect**, and press **OK**. If the wireless network is functioning, and a message "Connection to XXX...Success" will appear on the TV.
- Press **OK** to close the message. The BD disc player is now connected to the network. From now on, when you turn on the player, it will automatically connect to the network; there is no need to repeat these steps again.

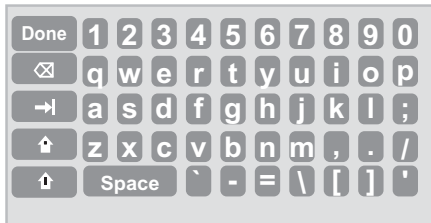
**Note:** If you do not see this message, the BD player was not able to connect to the network.

- If the BD player is connected to an **Encrypted Wireless Network**, a menu similar to the following will appear:



- Press **ENTER** to activate the on-screen keyboard. Carefully enter the network password by using the **▲ / ▼ / ◀ / ▶** to highlight the desired letter on the keyboard, and then pressing **OK**. (If you make a mistake, use the backspace key to erase the mistake.)

If the unit does not perform properly when operated as instructed in this manual, check the unit, consulting the following checklist.

Cannot connect to the network	- Check if the LAN cable connection is properly made. - Turn on the modem or broadband router. - Check if the broadband router and/or modem is correctly connected. - Check the "Network Connection Setting".
Cannot connect to the network while my PC is connected to the network	- Check the content of your Internet service contract to see if your Internet service provider prevents multiple terminals connecting at the same time.
Cannot use the BD-Live function	- Use an SD card with enough space.
The playback of BD-video or download of data does not perform properly	- Check if an SD Card is correctly inserted. Do not remove the card during playback as some BD-videos require an SD Card during playback.

### Notes

- Some functions are not available in specific modes, but this is not a malfunction. Read the description in this manual for details on correct operations.
- Some functions are prohibited on some discs.

## Maintenance

### Servicing

- Please refer to relevant topics on "Troubleshooting & Maintenance" before returning the product.
- If this unit becomes inoperative, do not try to correct the problem by yourself. There are no user-serviceable parts inside. Turn off, unplug the power plug, and please call our helpline to locate an Authorized Service Center.

### Cleaning the cabinet

- Never use a solvent, thinner, benzene or alcohol to clean the unit. Do not spray insecticide liquid near the unit. Such chemicals may discolor the surface or damage the unit.

### Cleaning discs

- When a disc becomes dirty, clean it with a cleaning cloth. Wipe the disc from the center to out. Do not wipe in a circular motion.
- Do not use solvents such as benzene, thinner, commercially available cleaners, detergent, abrasive cleaning agents or antistatic spray intended for analog records.

### Cleaning the disc lens

- If this unit still does not perform properly although you refer to the relevant sections and to "Troubleshooting" in this manual, the laser optical pickup unit may be dirty. Consult your dealer or an Authorized Service Center for inspection and cleaning of the laser optical pickup unit.

### Disc handling

- Handle the discs so that fingerprints and dust do not adhere to the surfaces of the discs.
- Always store the disc in its protective case when it is not used.
- Note that discs with special shapes (heart-shaped discs, octagonal discs, etc.) cannot be played back on this unit. Do not attempt to playback such discs, as they may damage the unit.

### IR signal check

- If the remote control is not working properly, you can use a digital camera (including a cellular phone with built-in camera) to see if it is sending out an infrared signal.

## Glossary

### Analog Audio

An electrical signal that directly represents sound. Compare this to digital audio which can be an electrical signal, but is an indirect representation of sound.

### Aspect Ratio

The width of a TV screen relative to its height. Conventional TVs are 4:3 (in other words, the TV screen is almost square); widescreen models are 16:9 (the TV screen is almost twice as wide as it is high).

### AVCHD

AVCHD is a new format for high definition video camcorders which can record and play high-resolution HD images.

### BD-Java

With some BD which support Java applications, you can enjoy the interactive functions such as games or interactive menus.

### BD-Live

BD-Live is a BD-video (BD-ROM version 2 Profile 2.0/Profile 1.1) which contains new functions (e.g. Internet connection), in addition to the BONUSVIEW function.

### Blu-ray 3D

Blu-ray 3D is a BD-video (BD-ROM version 3 Profile 5.0) which contains 3D view function, in addition to the BD-Live/BONUSVIEW function.

### Blu-ray Disc (BD)

Blu-ray Disc is a next generation optical video disc which is capable of storing much more data than a conventional DVD is. The large capacity makes it possible to benefit from the features such as high-definition videos, multi-channel surround sounds, interactive menus and so on.

### Chapter

Just as a book is split up into several chapters, a title on a BD-video or DVD-video is usually divided into chapters.

### Component Video Output

Each signal of luminance (Y) and component ( $P_B/C_B$ ,  $P_R/C_R$ ) is independent to output so that you can experience picture Color as it is.

Also, due to compatibility with progressive video (525p/480p), you can experience higher-density picture than that in interlace (525i/480i).

### Digital Audio

An indirect representation of sound by numbers. During recording, the sound is measured at discrete intervals (44,100 times a second for CD audio) by an analog-to-digital converter, generating a stream of numbers. On playback, a digital-to-analog converter generates an analog signal based on these numbers.

### DNS Server

A server which translates Internet domain names into IP addresses.

### Dolby Digital

The system to compress digital sound developed by Dolby Laboratories. It offers you sound of stereo (2ch) or multi-channel audio.

### Dolby Digital Plus

Dolby Digital Plus is the next generation digital audio compression technology developed as an extension to Dolby Digital. Blu-ray Disc supports 7.1 multi-channel surround sound output.

### Dolby TrueHD

Dolby TrueHD is a lossless coding technology developed for next generation optical discs. Blu-ray Disc supports 7.1 multi-channel surround sound output.

### DTS

DTS is a multi-channel surround sound system. By connecting to DTS decoder, you can enjoy movie dynamic and realistic sound like movie theater. DTS surround sound technologies were developed by DTS, Inc.

### DTS-HD

DTS-HD is a lossless coding technology developed as an extension of the original DTS Coherent Acoustics format. Blu-ray Disc supports 7.1 multi-channel surround sound output.

### Gateway

IP Address of the electronic devices (such as router) which provide Internet access.

### HDMI (High-Definition Multimedia Interface)

A digital interface between audio and video source. It can transmit component video, audio, and control signal with one cable connection.

### Hub

A device used for connecting multiple device to the network.

### IP Address

A set of numbers which are assigned to devices participating in a computer network.

### JPEG (Joint Photographic Experts Group)

JPEG is a method of compressing still picture files. You can copy JPEG files on BD-RE/-R, DVD-RW/-R, CD-RW/-R or SD Memory Card from a computer and play back the files in this unit.



## **Glossary**

### **LAN (Local Area Network)**

A group of computer networks covering a small area like a company, school or home.

### **Local Storage**

A storage area of sub contents for playing virtual packages on BD-video.

### **MP3 (MPEG audio layer 3)**

MP3 is a method of compressing files. You can copy MP3 files on BD-RE/-R, DVD-RW/-R, CD-RW/-R or SD Memory Card from the computer and play back the files on this unit.

### **PCM (Pulse Code Modulation)**

The most common system of encoding digital audio, found on CD and DAT. Excellent quality that requires a lot of data compared to formats such as Dolby Digital and MPEG audio. For compatibility with digital audio recorders (CD, MD and DAT) and AV amplifiers with digital inputs, this unit can convert Dolby Digital, DTS, and MPEG audio to PCM.

### **Proxy Server**

Proxy server is a server which acts as an intermediary between a workstation user and the Internet to ensure security.

### **Region Code**

Regions associate discs and players with particular areas of the world. This unit will only play back discs that have compatible region codes. You can find the region code of your unit by looking on the rear panel. Some discs are compatible with more than one region (or all regions).

### **Router**

A networking device which distinguishes the IP address assigned to each device and routing and forwarding information in the computer network.

### **Sampling Frequency**

The rate which sound is measured by a specified interval to turn into digital audio data. The numbers of sampling in one second defines as sampling frequency. The higher the rate, the better the sound quality.

### **Subnet Mask**

A mask which is used to determine what subnet an IP address belongs to.

### **Title**

A collection of chapters on BD-video or DVD-video.

### **Track**

Audio CD use tracks to divide up the content of a disc. The BD-video or DVD-video equivalent is called a chapter. See also "Chapter".

### **Virtual Package**

The function which copies data to other media (local storage) from the Internet and play the secondary video, secondary audio and the subtitle at the same time. The method of the playback varies depending on discs.

### **Windows Media™ Audio**

Windows Media™ Audio is the audio compressing technology developed by Microsoft. You can copy Windows Media™ Audio files on BD-RE/-R, DVD-RW/-R, CD-RW/-R or SD Memory Card from a computer and play them back on this unit.

### **x.v.Color**

"x.v.Color" is a promotion name given to the products that have the capability to realize a wide color space based on the xvYCC specifications and is a trademark of Sony Corporation.

## Preamble

This license, the Lesser General Public License, applies to some specially designated software packages—typically libraries—of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.
