## basics

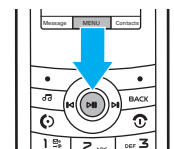

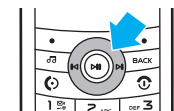
### turn it on & off


Press and hold  for a few seconds.

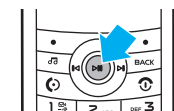
### menu navigation

Press  or **Select** (left soft key) to select the highlighted option.







## customize

Add your personal touch.

### set your wallpaper

Change the wallpaper image to one that makes you smile.

**Find it:**  >  Settings > Display > Wallpaper

- 1 If necessary, acknowledge the message about **Shuffle Multiple** by pressing .
- 2 To assign a single picture as a wallpaper, select **Single** and press , then scroll to the desired picture and press .
- To set your phone to show a random downloaded picture as a wallpaper, select **Shuffle Multiple** and press , then scroll to each downloaded picture you want and press . When you have selected all of the pictures you want, press **Done**.
- 3 Press  to return to the home screen.

## shortcuts

A few shortcuts we think you'll find really useful:

### voicemail

Press and hold **1**. (If your voicemail number is not pre-programmed, press **1**, then **Store**.) Call your service provider if you don't know the number.

### recent calls

Quickly see your call history by pressing **☰** > **Recent Calls**. You can then access your **Received Calls** or **Dialed Call** or your call **Timers**.

### your phone number

To see your own phone number, press **BACK**, then **#**.

### music player

**Note:** You must have a **microSD memory card** (available separately) installed in your phone to use the music player.

Press **🎵** from the home screen.

### lock/unlock keys

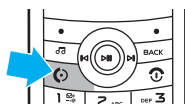
Prevent accidental calls by pressing and holding **#**. To **unlock** the keypad, press **Unlock** (the right soft key), then press **☰**.

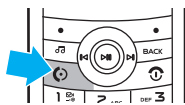

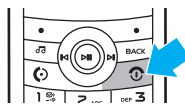

- 1 If necessary, press **☰** to acknowledge the message about **Shuffle Multiple**.
- 2 Select **Single Tone** to assign a single ringtone to incoming calls, then scroll to the ringtone you want and press **☰**.

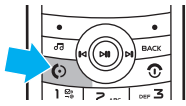
**Note:** Your phone plays each ringtone that you highlight.


Select **Shuffle Multiple** to set your phone to play a random downloaded ringtone for incoming calls. Scroll to each downloaded ringtone you want and press **☰**. After you select all of the ringtones you want, press **Done**.

**Note:** **Phonebook** entries with assigned **Ringer IDs** will not be affected. The **Shuffle Multiple** option works only with downloaded ringtones and depletes your battery's charge more quickly than **Single Tone**.

- 3 Press **☎** to return to the home screen.

## emergency calls





To call an emergency number, enter the emergency number and press .

Your service provider programs emergency phone numbers, (such as 112 or 911), that you can call under any circumstances, even when your phone is locked.

Emergency numbers vary by country. Your phone's pre-programmed emergency number(s) may not work in all locations, and sometimes an emergency call cannot be placed due to network, environmental, or interference issues.

## redial a number

- 1 From the home screen, press  to see a list of recently dialed calls.
- 2 Scroll to the entry you want to call and press .


## phonebook

*Met someone new? Save their number.*

### save contact

- 1 Enter the number on the home screen and press **Save**.
- 2 Select **Create New Contact**.
- 3 Enter the contact details.
- 4 Press **Save** when you're finished.

### call a contact

- 1 From the home screen, press **Contacts**.
- 2 Scroll through the list to highlight the contact's number.
- 3 Press .


## music

### Rock your world . . .

First, **load music onto your computer**. Then, **transfer the music to your phone** (using Windows® Media Player, or manually). **For instructions** on loading and transferring music, see your *User's Guide*.

**To activate the music player**, press . Your phone shows the **Music Player** menu, which includes:

- 2 Scroll down to the text entry area and enter message text.








**To insert a prewritten message**, press  to select **Insert**, then select **Quick Text**. Scroll to the quick text you want to insert and press .

- 3 **To insert a stored picture**, select **Insert**, then select **Pictures**. Scroll to the desired picture and press .










**To insert a sound**, select **Insert**, then select **Audio**. Scroll to the desired sound and press .

**To insert a Vcard for a contact** in your **Phonebook**, select **Insert**, then select **Contact Info**. Scroll to the desired entry and press .

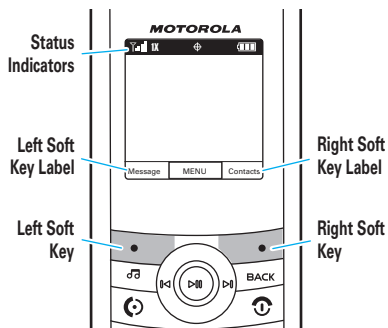
### read a message

When you receive a message, your phone plays an alert and displays the  (new message) indicator and a **New Message** notification.

Select **View Now** to read the message immediately, or select **View Later** to save it in your **Inbox** for viewing later.

## display

Your phone shows the *home screen* when you are not on a call or using the menu.



**Note:** Your phone's home screen may be different than the one shown.

Indicators at the top of your phone's display provide important status information, such as strength of signal, battery charge level, incoming calls, missed messages, and other conditions. See your *User's Guide* for a complete listing of status indicators.

## battery use & safety

**IMPORTANT: HANDLE AND STORE BATTERIES PROPERLY TO AVOID INJURY OR DAMAGE.** Most battery issues arise from improper handling of batteries, and particularly from the continued use of damaged batteries.

### DON'Ts

- **Don't disassemble, crush, puncture, shred, or otherwise attempt to change the form of your battery.**
- **Don't let the phone or battery come in contact with water.** Water can get into the phone's circuits, leading to corrosion. If the phone and/or battery get wet, have them checked by your carrier or contact Motorola, even if they appear to be working properly.
- **Don't allow the battery to touch metal objects.** If metal objects, such as jewelry, stay in prolonged contact with the battery contact points, the battery could become very hot.
- **Don't place your battery near a heat source.** Excessive heat can damage the phone or the battery. High temperatures can cause the battery to swell, leak, or malfunction. Therefore:
- Do **not** dry a wet or damp battery with an appliance or heat source, such as a hair dryer or microwave oven.
- Avoid leaving your phone in your car in high temperatures.

### DOs

- **Do avoid dropping the battery or phone.** Dropping these items, especially on a hard surface, can potentially cause damage.
- **Do contact your service provider or Motorola if your phone or battery has been damaged from dropping or high temperatures.**

**IMPORTANT: USE MOTOROLA ORIGINAL PRODUCTS FOR QUALITY ASSURANCE AND SAFEGUARDS.** To aid consumers in identifying authentic Motorola batteries from non-original or counterfeit batteries (that may not have adequate safety protection), Motorola provides holograms on its batteries. Consumers should confirm that any battery they purchase has a "Motorola Original" hologram.

**Motorola recommends you always use Motorola-branded batteries and chargers.** Motorola mobile devices are designed to work with Motorola batteries. If you see a message on your display such as **Invalid Battery** or **Unable to Charge**, take the following steps:

- Remove the battery and inspect it to confirm that it has a "Motorola Original" hologram;
- If there is no hologram, the battery is not a Motorola battery;
- If there is a hologram, replace the battery and retry charging it;
- If the message remains, contact a Motorola Authorized Service Center.

**Important:** Motorola's warranty does not cover damage to the phone caused by non-Motorola batteries and/or chargers.

**Warning:** Use of a non-Motorola battery or charger may present a risk of fire, explosion, leakage, or other hazard.

### PROPER AND SAFE BATTERY DISPOSAL AND RECYCLING

## Specific Absorption Rate Data

This model wireless phone meets the government's requirements for exposure to radio waves.

Your wireless phone is a radio transmitter and receiver. It is designed and manufactured not to exceed limits for exposure to radio frequency (RF) energy set by the Federal Communications Commission (FCC) of the U.S. Government and by the Canadian regulatory authorities. These limits are part of comprehensive guidelines and establish permitted levels of RF energy for the general population. The guidelines are based on

standards that were developed by independent scientific organizations through periodic and thorough evaluation of scientific studies. The standards include a substantial safety margin designed to assure the safety of all persons, regardless of age or health.

The exposure standard for wireless mobile phones employs a unit of measurement known as the Specific Absorption Rate, or SAR. The SAR limit set by the FCC and by the Canadian regulatory authorities is 1.6 W/kg.<sup>1</sup> Tests for SAR are conducted using standard operating positions accepted by the FCC and by Industry Canada with the phone transmitting at its highest certified power level in all tested frequency bands. Although the SAR is determined at the highest certified power level, the actual SAR level of the phone while operating can be well below the maximum value. This is because the phone is designed to operate at multiple power levels so as to use only the power required to reach the network. In general, the closer you are to a wireless base station, the lower the power output.

Before a phone model is available for sale to the public in the U.S. and Canada, it must be tested and certified to the FCC and Industry Canada that it does not exceed the limit established by each government for safe exposure. The tests are performed in positions and locations (e.g., at the ear and worn on the body) reported to the FCC and available for review by Industry Canada. The highest SAR value for this model phone when tested for use at the ear is **1.52 W/kg**, and when worn on the body, as described in this user guide, is **0.9 W/kg**. (Body-worn measurements differ among phone models, depending upon available accessories and regulatory requirements).<sup>2</sup>

While there may be differences between the SAR levels of various phones and at various positions, they all meet the governmental requirements for safe exposure. Please note that improvements to this product model could cause differences in the SAR value for later products; in all cases, products are designed to be within the guidelines.

1. In the United States and Canada, the SAR limit for mobile phones used by the public is 1.6 watts/kg (W/kg) averaged over one gram of tissue. The standard incorporates a substantial margin of safety to give additional protection for the public and to account for any variations in measurements.

## Safety and General Information

**This section contains important information on the safe and efficient operation of your mobile device. Read this information before using your mobile device.**

### Exposure to Radio Frequency (RF) Energy

Your mobile device contains a transmitter and receiver. When it is ON, it receives and transmits RF energy. When you communicate with your mobile device, the system handling your call controls the power level at which your mobile device transmits.

Your Motorola mobile device is designed to comply with local regulatory requirements in your country concerning exposure of human beings to RF energy.

### Operational Precautions

For optimal mobile device performance, and to be sure that human exposure to RF energy does not exceed the guidelines set forth in the relevant standards, always follow these instructions and precautions.

#### Product Operation

When placing or receiving a phone call, hold your mobile device just like you would a landline phone.

If you wear the mobile device on your body, always place the mobile device in a Motorola-supplied or approved clip, holder, holster, case, or body harness. If you do not use a body-worn accessory supplied or approved by Motorola, keep the mobile device and its antenna at least 2.5 centimeters (1 inch) from your body when transmitting.

Using accessories not supplied or approved by Motorola may cause your mobile device to exceed RF energy exposure guidelines. For a list of Motorola-supplied or approved accessories, visit our Web site at: [www.motorola.com](http://www.motorola.com).

### RF Energy Interference/Compatibility

Nearly every electronic device is subject to RF energy interference from external sources if inadequately shielded, designed, or otherwise configured for RF energy compatibility. In some circumstances your mobile device may cause interference with other devices.

### Follow Instructions to Avoid Interference Problems

Turn off your mobile device in any location where posted notices instruct you to do so. In an aircraft, turn off your mobile device whenever instructed to do so by airline staff. If your mobile device offers an airplane mode or similar feature, consult airline staff about using it in flight.

## Implantable Medical Devices

If you have an implantable medical device, such as a pacemaker or defibrillator, consult your physician before using this mobile device.

Persons with implantable medical devices should observe the following precautions:

- ALWAYS keep the mobile device more than 20 centimeters (8 inches) from the implantable medical device when the mobile device is turned ON.
- DO NOT carry the mobile device in the breast pocket.
- Use the ear opposite the implantable medical device to minimize the potential for interference.
- Turn OFF the mobile device immediately if you have any reason to suspect that interference is taking place.

Read and follow the directions from the manufacturer of your implantable medical device. If you have any questions about using your mobile device with your implantable medical device, consult your healthcare provider.

## Driving Precautions

The use of wireless phones while driving may cause distraction. Discontinue a call if you can't concentrate on driving.

Additionally, the use of wireless devices and their accessories may be prohibited or restricted in certain areas. Always obey the laws and regulations on the use of these products.

## Operational Warnings

Obey all posted signs when using mobile devices in public areas.







## Potentially Explosive Atmospheres

Areas with potentially explosive atmospheres are often, but not always, posted and can include fueling areas, such as below decks on boats, fuel or chemical transfer or storage facilities, or areas where the air contains chemicals or particles, such as grain dust, or metal powders.

When you are in such an area, turn off your mobile device, and do not remove, install, or charge batteries. In such areas, sparks can occur and cause an explosion or fire.

## Glass Parts

Some parts of your mobile device may be made of glass. This glass could break if the product is dropped on a hard surface or receives a substantial impact. If glass breaks, do not

## Seizures/Blackouts

Some people may be susceptible to epileptic seizures or blackouts when exposed to flashing lights, such as when playing video games. These may occur even if a person has never had a previous seizure or blackout.

It is always a good idea to hold the screen away from your eyes, leave the lights on in the room, take a 15-minute break every hour, and stop use if you are very tired.

## Caution About High Volume Usage



**Warning:** Exposure to loud noise from any source for extended periods of time may affect your hearing. The louder the volume sound level, the less time is required before your hearing could be affected. To protect your hearing:

- Limit the amount of time you use headsets or headphones at high volume.
- Avoid turning up the volume to block out noisy surroundings.
- Turn the volume down if you can't hear people speaking near you.

If you experience hearing discomfort, including the sensation of pressure or fullness in your ears, ringing in your ears, or muffled speech, you should stop listening to the device through your headset or headphones and have your hearing checked.

This limited warranty is a consumer's exclusive remedy, and applies as follows to new Motorola Products, Accessories and Software purchased by consumers in the United States or Canada, which are accompanied by this written warranty:

## Hearing Aid Compatibility with Mobile Phones

**T-Ratings:** Phones rated T3 or T4 meet FCC requirements and are likely to be more usable with a hearing device's telecoil ("T Switch" or "Telephone Switch") than unrated phones. T4 is the better/higher of the two ratings. (Note that not all hearing devices have telecoils in them.)

Hearing devices may also be measured for immunity to this type of interference. Your hearing device manufacturer or hearing health professional may help you find results for your hearing device. The more immune your hearing aid is, the less likely you are to experience interference noise from mobile phones.

## Notice to Hearing Aid Users

To maintain the published Hearing Aid Compatibility (HAC) rating for this mobile phone, use only the original equipment battery model. If the battery is replaced, confirm that the model number is BQ50 or BQ60.
