

#### **FUEL SAFETY**

- S Store unit so line limiter cannot accidentally cause injury. Unit can be hung by the tube. Store the unit out of the reach of children.


#### ADJUST THE HANDLE

\$ Loosenwingnut or plastic knob on handle. \$ Rotate handle to upright position and tighten in a comfortable position between the trigger and the safety label on the tube. Tighten handle securely.

#### ATTACHING THE SHIELD

**WARNING:** The shield must be properly installed. The shield provides partial protection from the risk of thrown objects to the operator and others and is equipped with a line limiter which cuts excess line. The line limiter (on underside of shield) is sharp and can cutyou.

- S Remove wing nut from shield.S Insert bracket into slot on shield.
- **\$** Pivotshielduntilboltpassesthroughholein bracket.
- Securely tighten wing nut.
- \$ Removepackingcoverfromthearborshaft if so equipped. Thread trimmer head onto shaft; tighten securely against dust cup.



#### FUEL YOUR UNIT

This engine is certified to operate on unleaded gasoline. Gasoline must be mixed with a good quality 2-cycle air-cooled engine oil designed to be mixed at a ratio of 40:1. Poulan/Weed Eaterr brand oil is recommended. (A 40:1 ratio is obtained by mixing 3.2 ounces of oil with 1 gallon of unleaded gasoline). When mixing fuel follow the instructions printed on the container. Always read and follow the safety rules under FUEL SAFETY.

#### HOW TO STOP YOUR UNIT

Push and hold the engine stop switch in the STOP or OFF position until the unit has fully stopped.



#### HOW TO START YOUR UNIT

WARNING: The trimmer head will turn while starting the engine. A hot muffler can cause serious burns.

#### COLD ENGINE STARTING OR STARTING AFTER REFUELING

- Set unit on a flat surface.
- Slowly press the primer bulb 6 times.
- Move choke lever to FULL CHOKE position.
- Squeeze the throttle trigger fully and hold through all remaining steps.
- \$ Pull starter rope handle sharply 6 times.
- \$ Move choke lever to HALF CHOKE position.
- \$ Pull starter rope handle no more than 6 pulls, until engine runs.






#### ADVANCING THE CUTTING LINE

Advanceline by tapping the bottom of the cutting head lightly on the ground while engine is running at full speed. The metal Line Limiter blade attached to the shield will cut the line to the proper length.

#### REPLACING THE LINE

- \$ Pushandholdtheenginestopswitchinthe STOP/OFF position until the unit has fully stopped.
- Disconnect the spark plug lead wire.
- Remove spool by firmly pulling on tap button.
- Clean entire surface of hub and spool.
- Replace with a pre-wound spool, or cuttwo lengths of 12-1/2 feet of .080" (2 mm) diameter Poulanr brand line. Never use wire, rope, string, etc., which can break off and become a dangerous missile.
- Insertends of the line about 1/2 inch (1cm) into the small hole on the inside of spool.





- \$ Wind the line evenly and tightly onto the spool. Wind in the direction of the arrows found on the spool.
- \$ Pushthelineintothenotches, leaving 3 to 5 inches (7 - 12 cm) unwound.
- Insert the line into the the exit holes in the hub as shown in the illustration.
- Align the notches with the line exit hole.
- Push spoolinto hub until it snaps into place.
- Pull the line extending outside of the hubto release it from the notch.

The ignition timing is fixed, non-adjustable.

#### **SPARK PLUG**

Replace the spark plug yearly using a Champion RCJ-8Y plug. Spark plug gap is .025".
