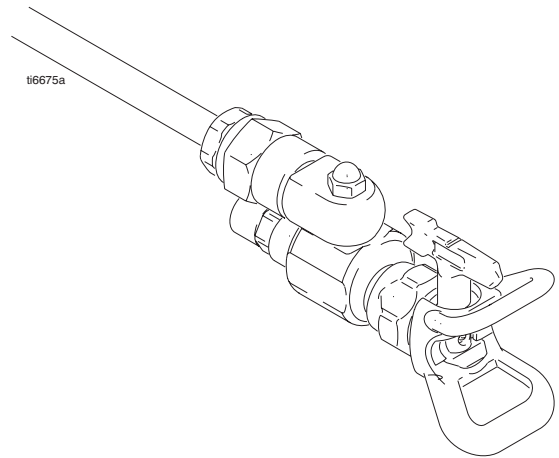

# Warnings

	<p><b>FIRE AND EXPLOSION HAZARD</b></p> <p>Flammable fumes, such as solvent and paint fumes, in <b>work area</b> can ignite or explode. To help prevent fire and explosion:</p> <ul style="list-style-type: none"> <li>• Use equipment only in well ventilated area.</li> <li>• Eliminate all ignition sources; such as pilot lights, cigarettes, portable electric lamps, and plastic drop cloths (potential static arc).</li> <li>• Keep work area free of debris, including solvent, rags and gasoline.</li> <li>• Do not plug or unplug power cords, or turn power or light switches on or off when flammable fumes are present.</li> <li>• Ground equipment and conductive objects in work area. 	<p><b>PRESSURIZED EQUIPMENT HAZARD</b></p> <p>Fluid from the gun/dispense valve, leaks, or ruptured components can splash in the eyes or on skin and cause serious injury.</p> <ul style="list-style-type: none"> <li>• Follow <b>Pressure Relief Procedure</b> in this manual, when you stop spraying and before cleaning, checking, or servicing equipment.</li> <li>• Tighten all fluid connections before operating the equipment.</li> <li>• Check hoses, tubes, and couplings daily. Replace worn or damaged parts immediately.</li> </ul>
	<p><b>EQUIPMENT MISUSE HAZARD</b></p> <p>Misuse can cause death or serious injury.</p> <ul style="list-style-type: none"> <li>• Do not exceed the maximum working pressure or temperature rating of the lowest rated system component. ## Pressure Relief Procedure

 **WARNING**



Follow **Pressure Relief Procedure** when you stop spraying and before cleaning, checking, servicing, or transporting equipment. Read warnings.

1. Engage trigger lock.
2. Close the bleed-type master air valve.
3. Disengage the trigger lock.
4. Hold a metal part of the gun firmly to a grounded metal pail. Trigger the gun to relieve pressure.
5. Engage the trigger lock.
6. Open all fluid drain valves in the system, having a waste container ready to catch drainage. Leave drain valve(s) open until you are ready to spray again.
7. If you suspect the spray tip or hose is clogged or that pressure has not been fully relieved after following the steps above, **VERY SLOWLY** loosen tip guard retaining nut or hose end coupling to relieve pressure gradually, then loosen completely. Clear hose or tip obstruction.

### Trigger Lock

Always engage the trigger lock when you stop spraying to prevent the gun from being triggered accidentally by hand or if dropped or bumped.

# Installation

## ⚠ WARNING

To reduce the risk of serious bodily injury from fluid injection or splashing in the eyes or on the skin, stop using the nozzle immediately if it starts to leak or cannot be turned easily.

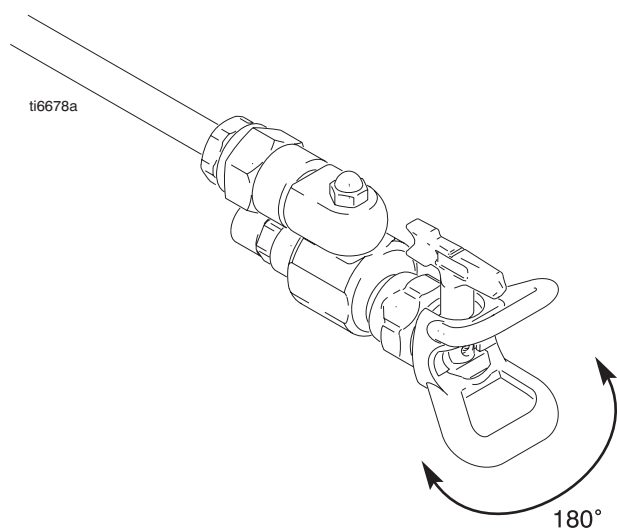


Fig. 1 \_\_\_\_\_

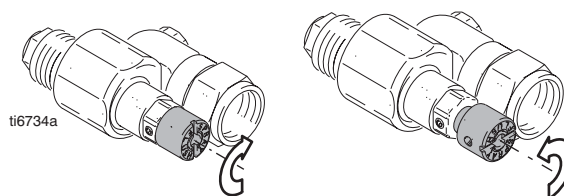


Fig. 2 \_\_\_\_\_

## Installing the Tip and Guard (Fig. 1 and Fig. 2)

- 1 Without the spray tip installed, start sprayer, turn the knob on the Low Overspray CleanShot Valve counter-clockwise to the FLUSH position (Fig. 2).
- 2 Flush and prime the spray system.
- 3 Follow the **Pressure Relief Procedure** described in the warning pages of this manual.
- 4 Install the spray tip.
- 5 Turn the knob of the Low Overspray CleanShot Valve to SPRAY (Fig. 2).
- 6 Rotate the Low Overspray CleanShot Valve to any desired position within 180°. Do not use any tools.
- 7 Refer to your separate gun instruction manual for operating and tip cleaning instructions.
- 8 This adapter is repairable.

## ⚠ CAUTION

To avoid damage to the o-ring in the swivel:

- Relieve fluid pressure before rotating the swivel.
- Do not soak the entire swivel in solvent.

## Flush and Spray

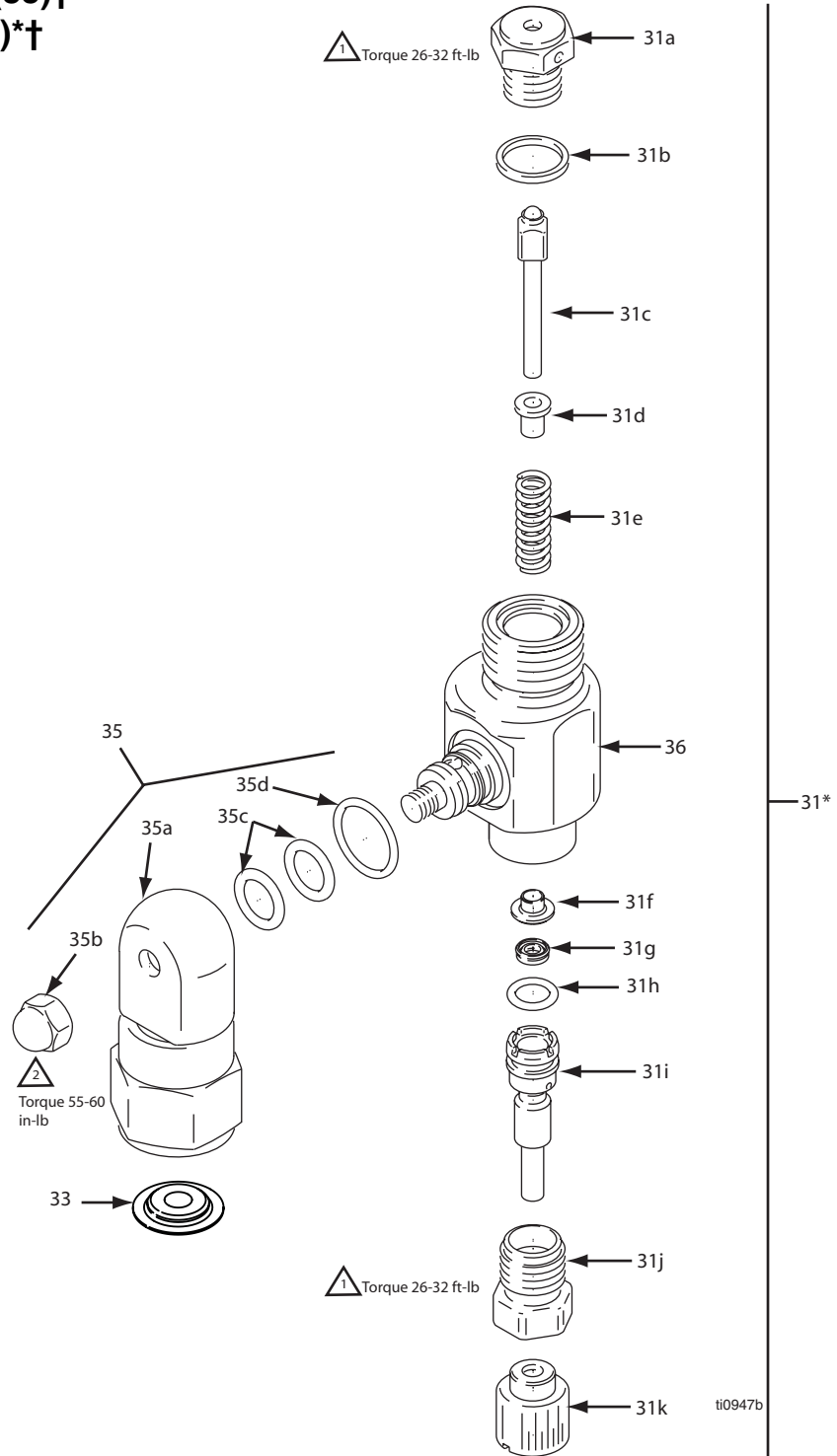
The Low Overspray CleanShot Valve provides two settings: SPRAY and FLUSH. The valve is factory set to the SPRAY position for spraying at pressures above 700 psi (4.8 MPa, 48 bar). Turn the valve (override) to the FLUSH position for flushing, cleaning, priming and relieving pressure. FLUSH is also used for low pressure spraying applications below 1000 psi (6.9 MPa, 69 bar).
